### Profile of Shri RVN Vishweshwar

Shri RVN Vishweshwar, Executive Director (Corporate Finance & Treasury), Indian Oil Corporation Limited (IOCL) has been appointed as Director (Finance), Hindustan Copper Limited (HCL) w.e.f. 29.07.2025 in terms of Order No. Met3-10/1/2024-METAL III) dated 25.07.2025 issued by the Ministry of Mines, Government of India.

Shri RVN Vishweshwar is B. Com(H), CMA, LLB and having more than 32 years of experience. Prior to joining HCL, Shri Vishweshwar was holding the post of Executive Director (Corporate Finance & Treasury), IOCL and was overall in charge of Corporate Finance and Treasury operations. During his career at IOCL, he was involved in core finance areas including finalization of accounts, banking, insurance, payroll, customer ledger, transportation, project payments etc. He was the key coordinator during ERP migration to SAP in the initial implementation stage. Shri Vishweshwar also handled Forex transactions - spot and derivatives, managed overall cash flow, monitoring for the purposes of risk management, arrangement of funds - Forex as well as domestic. He was also involved in activities related to Employee Benefit Trusts such as Provident Fund, Pension, Gratuity, Post Retirement Medical Benefit etc. He was the Team Lead for SAP - FICO group for about 4 years.
