Sub: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 - Glass Leakage Incident at Hindusthan National Glass & Industries Limited at its plant being Furnace No. 6 at Rishra, West Bengal.

In terms of Regulation 30 of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 ('SEBI LODR Regulations'), we wish to bring to your immediate attention a significant operational incident that has occurred at our Glass manufacturing facility located at Rishra, West Bengal.

Incident Summary:

On 3rd September 2024, at approximately 1:00 AM, a glass leakage incident occurred at Furnace No. 6, at Rishra, West Bengal. The leak occurred at the right-hand side throat gable wall of the Furnace as a result of which the glass level of furnace got reduced. The incident was identified promptly by our on-site operational team, and all necessary emergency protocols were activated to contain the situation. The Company has installed the latest firefighting equipments and was able to contain the damage successfully. However, the production at Furnace 6 has stopped. The Furnace is quite old which is the primary reason for the leakage. We are assessing the full extent of the operational disruption and doing a Root Cause analysis.

The Company is in receipt of a visit report dated September 12, 2024 from a technical expert and as per the said report, the furnace refractories are severely damaged. Even after the planned repairs by the plant, operating the furnace poses potential risks to the safety of the plant. Hence, the operational disruption caused due to closure of Furnace No. 6, may be considered as a material event and thus the Company is making the disclosure as per Regulation 30(4) SEBI LODR Regulations.
