This is further to our earlier communication dated 21<sup>st</sup> April' 2026 regarding the unfortunate fire incident that occurred on 20<sup>th</sup> April' 2026 in the Crude Distillation Unit (CDU) of HPCL Rajasthan Refinery Limited (HRRL), a Joint Venture Company of Hindustan Petroleum Corporation Limited.

Detailed investigations post the incident have confirmed the initial assessment that the fire was localized in the heat exchanger stack impacting only 6 exchangers and their supporting equipment. Basis circumstantial evidence, the cause of fire is suspected to be leakage from pressure gauge tapping point on the vacuum residue exchanger inlet line.

The restoration work is in progress and it is expected to get completed in next 3-4 weeks. CDU restart is anticipated in 2<sup>nd</sup> fortnight of May' 2026. The other secondary Units are already under advanced stage of commissioning as per plan.

It is expected that the trial production of main products (LPG/MS/HSD/Naphtha) would start within May' 2026 and thereafter the Units would be stabilized / commissioned.
