i.	Name of the authority	The Collector and Additional Superintendent of Stamps, Gandhinagar.

Nature and details of the action taken, initiated or order passed	The Company has received an order from the Collector and Additional Superintendent of Stamps with demand for stamp duty of Rs.26,49,156/- and fine of Rs.1,58,94,936 /- on the moveable and immoveable properties transferred pursuant to the Slump sale agreement dated May 30, 2006 executed between Mipak Plastics Private Limited and Mipak Polymers Private Limited [which later on, pursuant to Scheme of Amalgamation got merged with Clear Plastics Limited (subsequently known as Clear Mipak Packaging Solutions Limited) vide Hon'ble Bombay High Court's order dated May 07, 2010, which further got merged with Hitech Corporation Limited ("the Company") vide order dated November 20, 2015 passed by Hon'ble High Court of Bombay].
iii.	Date of receipt of direction or order, including any ad-interim or interim orders, or any other communication from the authority	August 05, 2025.
iv.	Details of the violation/contravention committed or alleged to be committed	Mipak Plastics Private Limited through a Slump Sale Agreement dated May 30, 2006, transferred ownership to Mipak Polymers Private Limited which later on, pursuant to Scheme of Amalgamation got amalgamated with Clear Plastics Limited (CPL) vide order dated May 07, 2010, and became "Clear Mipak Packaging Solutions Limited", subsidiary of Hitech Corporation Limited ("the Company") which further got merged with the Company vide order dated November 20, 2015, passed by Hon'ble High Court of Bombay. The Company had paid the requisite stamp duty on both the above orders after due adjudication. During that period, Mipak Polymers Private Limited had paid a stamp duty of Rs.5,82,640/- on the abovementioned Slump Sale Agreement to the Maharashtra State Stamp Authority.
		The Gujarat State Stamp authority has now sought to levy Stamp Duty on the moveable and immoveable properties transferred through the above-mentioned slump sale
