Subject: Expands Cold Pressed Mustard Oil Production Capacity

Dear Sir/Madam,

Pursuant to Regulations 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we are pleased to announce that HOAC Foods India Limited is enhancing its **cold pressed mustard oil** production facility. Our current production capacity is **200 litres per day**, contributing approximately **10% of our total revenue**. With our existing setup operating at full capacity, we are now upgrading our machinery to increase production to **1,000 litres per day**.

This expansion is expected to significantly boost our revenue. Currently, our mustard oil facility generates **₹2 crore annually**, and with the enhanced capacity, we anticipate revenue growth to approximately **₹8 crore annually**. Additionally, we process **yellow mustard oil and black mustard oil** in the same facility.

With this new machinery, we will also begin the production of **cold pressed yellow mustard oil and cold pressed black mustard oil**, introducing **two new SKUs** to our product lineup. This expansion will allow us to cater to a wider consumer base seeking premium-quality cold pressed oils.

A key by-product of mustard oil extraction is **mustard cake**, which amounts to approximately **3,80,000 kg annually**. This is marketed under our brand **Hariom Pashu Ahar** and contributes an estimated **₹87.4 lakh in revenue annually**.

With this upgraded production capacity, we will expand our **cold pressed mustard oil** distribution beyond our existing channels, reaching **kirana stores and third-party retailers** in the open market. This strategic move aligns with our vision of strengthening our market presence and driving further growth for HOAC Foods India Limited.
