Subject: Launch of New FMCG Products

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform the Exchange that HOAC Foods India Limited has launched additional FMCG products comprising **Almond Oil, Mungfali (Groundnut) Oil, Pasta and Macaroni**, as part of its ongoing product portfolio expansion strategy; the newly introduced edible oil products shall be made available through an exclusively designed oil-focused store format and will also be distributed across all existing Hariom Atta & Spices outlets, along with the Company's established retail and distribution network, while Pasta and Macaroni will be offered through the same distribution channels; prior to this launch, the edible oil category contributed approximately **10% to the Company's total revenue**, and with the combined introduction of the above-mentioned products, the overall revenue **contribution is expected to increase to approximately 13%–15%**, subject to market conditions and consumer demand; further, all these products are margin-accretive in nature and are aligned with the Company's ongoing efforts to strengthen its FMCG portfolio, improve operational efficiency, enhance overall profitability, and support sustainable long-term growth; this disclosure is made for the information of the Exchange and for record purposes.
