## WB's Heena sets national record in girls' Under-16 300m sprint

**GUWAHATI:** Rezoana Mallick Heena of West Bengal set U-16 national record in girls' 300m race at the National Junior Athletics Championships here on Saturday. Heena clocked 38.57 seconds to improve on Karnataka sprinter Unnati Aiyappa's earlier national mark of 40.11 seconds set last year. Uttar Pradesh high jumper Khyati Mathur was another athlete who broke a meet record, winning the girls' U-18 event with a clearance of 1.79m to improve on M Jishna's mark of 1.77m in Mangalagiri in 2019. In the track events, Deepak Rohilla (Haryana) and Priya H Mohan (Karnataka) emerged fastest in the Under-20 men and women's 400m sprints. Deepak Rohilla won in 47.50 seconds while Priya Mohan was home in 53.94 seconds.

## RCB trade Behrendorff to MI

**NEW DELHI:** Royal Challengers Bangalore have traded Australian fast bowler Jason Behrendorff to Mumbai Indians for the forthcoming Indian Premier League season.

Behrendorff was acquired by RCB in the 2022 IPL auction for a base price of Rs 75 lakh. Behrendorff has previously represented the Chennai Super Kings in 2021, Mumbai Indians in 2018 and RCB in 2022. The left-arm quick has played nine T20s, picking up seven wickets with a best bowling performance of 4-21.

## I-League: Perfect start for Gokulam

**MALAPPURAM (KERALA):** Defending I-League champions Gokulam Kerala defeated a wasteful Mohammedan Sporting 1-0 to kick off their campaign on a positive note here on Saturday. Gokulam's Cameroon signing Auguste Somlaga struck the all important goal in the 55th minute to give them full points, while the Kolkata heavyweights failed to make use of any of their opportunities. After a goal-less stalemate in the first 45 minutes, the home side started with urgency in the second-half.

**PUNE:** Bengal Warriors put up an inspiring performance to defeat Gujarat Giants 46-27 in a Pro Kabaddi League Season 9 match here on Saturday. Napoli could end the year with a double-digit points lead at the top of Serie A. Goals from Victor Osimhen, Piotr Zielinski and Eljif Elmas saw Napoli beat Udinese 3-2 on Saturday for their 11th straight league victory and open up a significant gap over their rivals.

It was a nervy finale for the home side, however, following two late goals from substitutes Iljija Nestorovski and Lazar Samardzic. The five teams immediately below Napoli don't play until Sunday, with four of them facing each other.

Whatever happens, Napoli are guaranteed to spend the rest of the year at least eight points clear as Serie A pauses for the World Cup and the traditional winter break.

By the time Italian football re-

headed home Elmas' cross for his seventh goal in his past six league matches.

Osimhen also had a hand in Napoli's second goal in the 31st as he went on the counterattack and sent a cheeky backheel pass

to Hirving Lozano in midfield. Lozano picked out Zielinski, who took one touch to control in the penalty area before curling into the far side of the net.

## PSG rests Marquinhos

Brazil defender Marquinhos has been rested for Paris Saint-Germain's final game before the World Cup in Qatar because of muscle discomfort.

French league leaders PSG said on Saturday that their captain Marquinhos, who is a key player in coach Tite's Brazil team and has made 71 international appearances, would be left out of the side to face Auxerre on Sunday.

But Argentina star Lionel Messi, France striker Kylian Mbappe and Brazil's Neymar will be included in the PSG squad before flying out to Qatar.

Messi missed last weekend's game against Lorient because of inflammation on his Achilles tendon, with central defender Presnel Kimpembe rested for a similar problem.

## Liverpool boss Jurgen Klopp issued one-game ban

Liverpool: Jurgen Klopp has been handed a one-match touchline ban after he was sent off in Liverpool's win against Manchester City last month. The English Football Association

successfully appealed against the decision to only fine Klopp for his outburst at an official in the highly charged Premier League game at Anfield.

Klopp was initially fined £30,000 by an independent regulatory commission over his conduct on Oct. 16. The FA felt that was too lenient and an independent appeal board on Friday suspended Klopp from the touchline with immediate effect. Klopp was also warned about his future conduct. Liverpool play on Saturday against Southampton at Anfield. — AP

## Gladbach dumps Dortmund into Bundesliga break

Berlin: Borussia Dortmund's trying week ended with a final sting when Jonas Hofmann led Borussia Monchengladbach to a 4-2 rout of his former team in the Bundesliga.

It was Dortmund's second loss in four days after falling at Wolfsburg 2-0 on Tuesday, and it potentially leaves the team nine points behind leaders Bayern Munich for the league's extended winter break.

Dortmund's pride was already hurt on Thursday when Mats Hummels and Marco Reus were left out of Germany's World Cup squad. Reus has been laboring with an ankle injury while Hummels, also 33, was omitted to "give a younger player a chance," Germany coach Hansi Flick said. — AP

## Argentina taking fewer forwards than Brazil

AP / Buenos Aires

Argentina are taking nine defenders, seven midfielders and seven forwards to the World Cup in Qatar as coach Lionel Scaloni's team aims to build on its Copa America success.

Scaloni announced his 26-player squad — which contains two fewer forwards than the roster for traditional rivals Brazil — in a video on Friday.

He is scheduled to speak about his choices on Monday.

Argentina won the Copa America in 2021, their first major trophy in 28 years. The World Cup squad has 21 players from the Copa America.

Lionel Messi's team is unbeaten in 35 matches. The 35-year-old Messi, who will play his fifth and likely last World Cup, is joined by other veterans including striker Angel Di Maria.
