Pursuant to Regulation 30 read with Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and in continuation of our earlier disclosure dated 29th September, 2025, submitted to the Stock Exchanges regarding the Show Cause Notice dated 23rd September, 2025, received by the Company from the Office of the Jt. Commissioner of Customs – (NS – I) Nhava Sheva, Raigad (“the Customs”), ascertaining Customs duty (Anti Dumping Duty) dues totaling to Rs. 28,70,934/- along with applicable interest under Section 28AA of the Customs Act, 1962.
