Amid heat from Congress, Tharoor slams 'zealots': Spoke about reprisals for terrorism

AMID CONGRESS leaders' jibe at him over his "surgical strike" remarks and suggesting that the BJP should name him its "super spokesperson", party MP Shashi Tharoor clarified on Thursday that for those "zealots" fulminating about his supposed igno-

rance of Indian valour across the LoC", he was "clearly and explicitly" speaking only about reprisals for terrorist attacks and not previous wars.

Tharoor, who is leading a multi-party delegation as part of the government's global outreach against terror emanating from Pakistan, said, "... For those zealots fulminating about my supposed ignorance of Indian

valour across the LoC in the past — I was clearly and explicitly speaking only about reprisals for terrorist attacks and not about previous wars."

"My remarks were preceded by a reference to the several attacks that have taken place in recent years alone, during which previous Indian responses were both restrained and constrained by our responsible respect for

the LoC and the IB," Tharoor said.

'Critics, trolls welcome to distort my views'

"But as usual," Tharoor, who also heads the Parliamentary Standing Committee on External Affairs, said, "critics and trolls are welcome to distort my views and words as they see fit. I genuinely have better things to do."

Two get jail terms for Indian family's death

TWO MEN have been sentenced to jail in the US for their roles in a human trafficking racket that resulted in the death of an Indian couple and their two children in January 2022.

Harsh Kumar Ramanlal Patel, 29, and his co-conspirator Steve Anthony Shand, 50, were part of a large-scale human-smuggling operation that brought Indian nationals to Canada on fraudulent student visas and then smuggled them into the US across the northern border.

Ramanlal Patel, an Indian national from Florida, was sentenced to 10 years and one month in prison for his role in the conspiracy. He will be deported from the US following his sentence.

Shand was sentenced to six years and six months in prison, followed by two years of supervised release, the US Department of Justice said in a statement on Wednesday.

In January 2022, four family members -- Jagdish Patel, 39, Vaishaliben Patel, 37, Vihangi Patel, 11 and Dharmik Patel, 3, were found frozen to death near Emerson, Manitoba, approximately 12 metres from the Canada-US border, while attempting to enter America illegally.
