INDIA-LED CARTEL IN GOVERNMENT PROCUREMENT

CCI penalises HP India ₹127 cr for bid rigging

THE COMPETITION COMMISSION of India (CCI) on Monday held tech giant HP India liable for orchestrating bid-rigging through its 16 authorised resellers in the Government e-Marketplace (GeM) tenders. The regulator imposed a penalty of ₹126.87 crore on the firm.

The CCI found HP India guilty of cover bidding, price fixing, and dividing the tenders among themselves for supplying printer ink and toner cartridges between 2017 and 2020.

In two separate orders involving HP's personal system products (such as laptops, desktops, notebooks, workstations) and printer consumables, the commission said HP India coordinated bids among its reseller network by selectively issuing Manufacturer Authorisation Forms (MAFs), which is a mandatory certificate required from the original manufacturer to bid on government tenders.

According to one CCI order, the collusion revolved around the transition to the GeM portal in 2017. Before GeM, these resellers had developed legacy commercial relationships with government departments, and such accounts were termed as "Most Valuable Customer" (MVC). When the new GeM portal introduced open competition, HP India's resellers started losing their MVC account business to new rivals.

In its defence, HP India argued it was not the "kingpin" of the cartel, claiming it was forced into the arrangement because resellers threatened to shift to low-cost counterfeit products if the company refused to provide support. On the other hand, resellers argued that to maintain business and meet sales targets set by HP India, they had to coordinate pricing and discounts for specific tenders floated on the GeM portal.

"Transparency introduced by the GeM framework allowed these incumbent resellers to track other competing resellers who had previously not serviced the government customer accounts but were now competing for the GeM tenders issued

by them." This shift adversely impacted the commercial interests of these incumbent resellers, the CCI said.

To minimise their loss, certain resellers approached HP India to devise an arrangement that would enhance their chances of securing government supply contracts against other competing HP India resellers. The CCI's probe found that HP India issued MAF selectively to its resellers. It gave them only to preferred resellers or those who agreed to cooperate with them, effectively blocking genuine outside competitors from participating in the tenders.

To create the illusion of competition, the incumbent resellers routinely engaged in

"cover bidding". When an incumbent reseller who had previously serviced the tendering government entity wanted a specific contract, it would request HP India to arrange such "cover bids". In some cases, the fellow resellers or sister companies were asked to submit intentionally higher or non-competitive bids. This ensured that the tender met the government's minimum requirement of three participants without creating real competition.

"The Director General (DG) has also brought to light the aspect of use of sister entities by some resellers to meet the requirement of minimum participation. Such sister concerns have participated in order to give a façade of competition," the order said. During its investigation, the DG found communications between HP India and its resellers in addition to communications among resellers which showed that they were in direct contact with each other through emails and WhatsApp groups.

The CCI rejected both defenses. The regulator concluded that the transparent bidding process was deliberately manipulated, thereby depriving government departments of competitive market rates. The cases originated from HP India's leniency application filed with CCI, with the company later admitting to the competition law violations and cooperating with the probe.

BSNL posts 100% revenue growth in Q1

STATE-RUN TELECOM OPERATOR Bharat Sanchar Nigam Limited (BSNL) has reported a nearly 10% year-on-year rise in revenue for the first quarter of financial year 2026-27, driven largely by strong growth in its enterprise and consumer mobility segments, Union Telecom Minister Jyotiraditya Scindia said on Monday.

"As far as our total revenue is concerned, directly from busi-



ness operations, we have posted close to about a 10% increase in revenue over last year.

Last year, we closed Q1 at ₹4,017 crore. This year, we

have closed Q1 at ₹4,418 crore. So there's a delta of ₹401 crore, an increase," Scindia said while announcing the provisional figures to the media.

He added that BSNL's ARPU (average revenue per user) has provisionally increased from ₹100 to ₹102.7.

Enterprise Business vertical grew the fastest, rising from ₹1,463 crore to ₹1,745 crore, a 19.2% year-on-year increase. Meanwhile, the Consumer Mobility segment grew from ₹1,594 crore to ₹1,724 crore, an

8% increase from Q1 last year. BSNL noted that the figures presented are provisional, with final numbers expected within the week.

Meanwhile, BSNL's turnaround, though gaining momentum, has come with significant challenges. BSNL's net loss for FY 2025-26 had more than doubled to ₹4,738 crore, as a weak fourth quarter erased earlier gains and the company missed its full-year revenue target by more than ₹7,000 crore.

June retail inflation rises to 18-mth high of 4.38%

"BUT THE EARLIER (fuel price) hikes will still add around 0.5 percentage points to headline inflation over the next year," he said.

CPI inflation averaged 3.9% in the June quarter, lower than the RBI's projection of 4.2% for the quarter. Inflation is projected to rise moving ahead due to an increase in food prices and the impact of the US-Iran conflict, which has flared up again pushing crude oil prices and freight costs higher.

The RBI in June projected CPI inflation to rise to 5.1% in the September quarter and average 5.1% in 2026-27 (Apr-Mar). Even as the RBI projected higher inflation going ahead, its Monetary Policy Committee (MPC) left the repo rate unchanged at 5.25% in June.

Some economists expect the MPC to raise interest rates in the coming months to combat the rising inflation. "The central bank left interest rates unchanged at its meeting last

month, but with inflationary pressure building, we think it is only a matter of time before the central bank begins a hiking cycle," Shah said. "A first hike in August is a growing possibility."

RBI Governor Sanjay Malhotra last month said it was premature to talk about raising interest rates. The central bank was watching for the second round impact of higher oil prices on inflation before taking a call on rates, Malhotra had said.

Minutes of the June MPC meeting showed other panel members also favored a "wait and watch" approach before moving to raise interest rates.

"While policymakers will remain vigilant to weather-related and geopolitical risks, the lack of discernible spillovers into demand should limit any market tendency to bring forward rate hike expectations," said RDBhika Rao, senior economist at Radhika Bank.

SC refers Kalyani family dispute to mediation

THE ASSETS INCLUDE extensive real estate holdings and stakes in several listed Kalyani Group companies, including Bharat Forge and Kalyani Steels, which continue to be managed by Baba Kalyani. There is no indication that the litigation has affected the operations of the group's listed companies.

The Supreme Court's intervention came after Hiremath challenged a Bombay High Court order of May 4, 2026, which declined to refer the matter to mediation after Baba Kalyani opposed the move. The High Court had held that mediation under the Mediation Act, 2023, is consensual and cannot be imposed on an unwilling party.

Appearing before the apex court, counsel for Baba Kalyani argued that three earlier attempts at mediation had failed—before the Supreme Court in 2018, a district court in 2024 and another attempt this year. They contended that the dispute involved multiple companies, family branches and public shareholders, making it far more complex than a conventional family settlement.

The Bench, however, urged all parties to make one more sincere effort to resolve the dispute. At the outset, the court observed that persuading the parties to mediate was akin to "taking an unwilling horse to the pond", but maintained that the effort was nevertheless

worthwhile.

Chief Justice Surya Kant said mediation succeeds only when senior counsel persuade clients to move beyond litigation and focus on preserving family relationships. The Bench also remarked that all sides were financially well placed and should devote their energies to more constructive pursuits.

To underline the point, the Bench recounted how an earlier dispute between two brothers from another business family was resolved after the elder sibling sought respect rather than wealth. "Such is the miracle and magic of mediation," the court observed.

Baba Kalyani's counsel sought a time-bound mediation while requesting that proceedings before the Bombay High Court continue in parallel. The Supreme Court declined the request, staying all related proceedings for the duration of the mediation and directing the parties to approach Justice Rao without delay, observing that there remained a genuine possibility of settlement.

The hearing featured some of the country's leading lawyers. Hiremath was represented by Senior Advocate Shyam Divan, along with Karanjawala & Co and RJD & Partners. Baba Kalyani's side was represented by Senior advocates Abhishek Manu Singhvi, Kapil Sibal and Aryama Sundaram.

Top court seeks aviation rules amid scrutiny of airfare pricing

THE CONCERNS OF price hikes gained prominence during the Maha Kumbh, when both bookings and airfares to Prayagraj witnessed steep increases as demand surged.

According to an analysis by travel portal ixigo, one-way airfare on the Bhopal-Prayagraj route jumped 498% to ₹17,796 from ₹2,977 a year earlier.

Airfares on the Delhi-Prayagraj route also rose by up to 21% during the period.

Similar spikes are witnessed during almost every festive season, with airfares typically increasing by 20-100% as demand peaks.

Under the existing regulatory framework, airfares in normal circumstances are market-driven and are neither fixed nor regulated by the government.

Following the repeal of the Air Corporations Act in March 1994, tariff fixation was deregulated, allowing airlines to determine fares under Rule 135(1) of the Aircraft Rules, 1937, after taking into account factors such as operating costs, characteristics of service, reasonable profit and prevailing market tariffs.

As a result, ticket prices generally fluctuate based on market forces and demand-supply dynamics, with airlines free to adopt dynamic pricing models.
