**GAIL and MOL Sign a Long-Term Charter Contract for an LNG Carrier**

**New Delhi, January 28, 2026:** GAIL (India) Limited, a Maharatna PSU, and Mitsui O.S.K. Lines Ltd (MOL), Tokyo, entered into a long-term charter agreement for an LNG carrier named “GAIL BHUWAN”. The signing ceremony was held on 27th January 2026 during India Energy Week 2026 in Goa. The agreement was signed between Shri. S Bairagi, Executive Director (International Shipping & LNG), GAIL and Mr. Hisashi Umemura, Director General, Headquarters of Energy Business, MOL, in the presence of CMD, GAIL and functional directors of GAIL along with dignitaries from MOL.

GAIL (India) Limited and MOL share a long-standing business partnership, and this collaboration further strengthens cooperation in LNG shipping and energy logistics. Relying on MOL’s proven track record in providing reliable transportation services—including its high standards of safety and quality—and strong partnership, this contract has been signed between GAIL (India) Limited and LNG Japonica Shipping Corporation Limited, a Joint Venture between GAIL (India) Limited (26%) and MOL (74%). The agreement marks an important milestone under the ‘Maritime Amrit Kaal Vision 2047’, reinforcing India’s maritime and energy supply chain capabilities. Both GAIL (India) Limited and MOL have set the ambitious net zero emission targets, and this agreement contributes to the realization of a low- and decarbonized society.
