e	Rationale	The entire MNJPL Pipeline is completed, and pre-commissioning and commissioning activities are currently underway in various sections.  The <b>Mumbai-Nagpur Section</b> as well as the <b>Chhattisgarh and Odisha Section of the Nagpur-Jharsuguda section</b> have already been operationalized.  The remaining part of the MNJPL is expected to be ready for gas-in by February 2026.

Further, approval for extension in completion schedule of MNJPL Project is being taken up with PNGRB.

It was approved by the Board of Directors of the Company in its meeting held today i.e. 31.01.2026 which commenced at 02:00 p.m. and concluded at 05:15 p.m.
