In furtherance to our intimation letter dated 16th July, 2025, relating to raising funds by the issue of Non-Convertible Debentures ("NCDs") on Private Placement basis and in accordance with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements), Regulations 2015, we wish to inform that the Finance Committee of the Company, at its meeting held on 4th December, 2025, approved the allotment of 280 (Two Hundred Eighty Only) Unlisted, Senior, Secured, Unrated, Taxable, Redeemable Non-Convertible Debentures (NCDs), of face value of Rs. 1,00,000/- each at an issue price of Rs. 1,00,000/- each aggregating Rs.2,80,00,000/- (Rupee Two Crore Eighty Lacs only) on Private Placement basis.
