In furtherance to our intimation letter dated 6th June, 2026, relating to raising funds by the issue of Non-Convertible Debentures ("NCDs") on Private Placement basis and in accordance with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements), Regulations 2015, we wish to inform that the Finance Committee of the Company, at its meeting held on 11th September, 2026, approved the allotment of 46 (Forty Six Only) Unlisted, Senior, Secured, Unrated, Taxable, Redeemable Non-Convertible Debentures (NCDs), of face value of Rs. 1,00,000/- each at an issue price of Rs. 1,00,000/- each aggregating Rs. 46,00,000/- (Rupees Forty Six Lakh Only) on Private Placement basis.
