## RAJKOT GAME ZONE FIRE

Have got green signal to question even senior IAS and IPS officers, says SIT chief

THE CHIEF of the special investigation team (SIT) set up to probe Rajkot's TRP game zone fire that killed 27 said on Wednesday that they have been given the go-ahead to question even senior IAS and IPS officers if the probe warranted.

SIT chief Subhash Trivedi spoke to the media after Gujarat Minister of State for Home Harsh Sanghavi met the SIT members in Gandhinagar and reviewed the progress in the probe. "We have been instructed to probe the roles of officers associated with Rajkot Municipal Corporation, fire department, police and power utility firm and take stern action if they are found guilty," said Trivedi.

A massive fire at the TRP Game Zone, a recreation facility, claimed the lives of 27 people, including children, on May 25, prompting the state government to set up the SIT.

"MoS Home (Sanghavi) has clearly told us to question even senior government employees, including IAS and IPS officers, if needed. In the coming days, they will be called by the SIT for the purpose of investigation. The SIT is also probing the role of each of the seven government employees, including two police officers,

who were already suspended," said Trivedi.

Since the game zone operators had stored over 30 litre of petrol on their premises, which was beyond the permissible limit, relevant sections will be added to the FIR under the Petroleum Act, he added.

"The minister has asked us to conduct a thorough probe so that action can be taken against those who were responsible for this tragedy. This is a fool-proof case. A commercial structure was erected on a piece of land without acquiring NA (non-agriculture) clearance. Police will record statements under section 164 of CrPC," Trivedi said. Section 164 of the Code of Criminal Procedure (CrPC) pertains to recording of statement by a magistrate.

Trivedi further said Director General of Police Vikas Sahay is supervising the probe being conducted by the Rajkot Police into the incident.

The SIT comprises the commissioner of technical education, B N Pani; director of Gandhinagar-based forensic science laboratory H P Sanghvi; Ahmedabad's chief fire officer JN Khadia and MB Desai, the supervising engineer of the roads and buildings department. A separate investigation is being conducted by the Rajkot Police that have arrested five persons so far.

IN 5TH ARREST, ANOTHER GAME ZONE PARTNER HELD

## Co-owner dead, confirm cops

FOUR DAYS after the game zone tragedy in Rajkot, investigators on Wednesday confirmed that one of the co-owners was among the 28 people killed in the fire. Prakashchand Hiran alias Prakash Jain, also among the six TRP Game Zone partners facing charges of culpable homicide (not amounting to murder) over the fire, was reported missing by his family on Monday. The DNA test results have confirmed his death, officials said.

In all, 28 people are feared to have been killed in the fire, with the 28th victim being listed as "human remains" in the first information report (FIR) filed in the accident. Rajkot Collector Prabhav Joshi announced that DNA samples of 27 victims, whose charred bodies were recovered from the rubble, have been matched with their family members and that there are no more missing people now, PTI reported.

Meanwhile, in the latest arrest in the case, another game zone co-owner, Kiritsinh Jadeja, was held on Tuesday night. He is the fourth co-owner and the fifth accused to be arrested amid the investigation. Dhaval Thakkar, who, as per police, was the main person controlling affairs of the TRP Game Zone, is among the five arrested so far.

On Hiran's death, Parthrajsinh Gohil, Deputy Commissioner of Police, Rajkot Crime Branch, said, "We had information that Hiran,

the other main operator (of the gaming zone) had been killed in this accident. That has now been confirmed by DNA testing." Gohil is supervising the Special Investigation Team (SIT) probing the criminal case registered after the fire.

Bharat Basiya, Assistant Commissioner, Rajkot Crime Branch and head of the SIT, said that Hiran hailed from the Rajsamand district of Rajasthan. "His brother had come to Rajkot from Vadodara and given a missing person's application to Rajkot Taluka Police station, stating Hiran was untraceable. Subsequently, DNA samples of their mother were taken for identification of those killed in the fire. DNA of the mother matched with that extracted from the body of one of the victims, confirming that the body was of Hiran," Basiya said.

"Hiran held a 60 per cent stake in the gaming zone. He was the one who took on board others as

partners for operationalising the venture," he added.

Meanwhile, Rajkot Police arrested Kiritsinh Jadeja, one of the owners of the party plot where the game zone was set up at the Nana Mava Road. "We picked up Kiritsinh Jadeja on Tuesday evening from Rajkot and arrested him formally at 10.30 pm," Basiya told The Indian Express. Of the six accused named in the FIR, including Hiran, police have so far arrested four.

Nitin Jain, a TRP gaming zone manager who was not initially booked has also been arrested. "Kiritsinh is the younger brother of Ashoksinh Jadeja and the two brothers are the owners of the

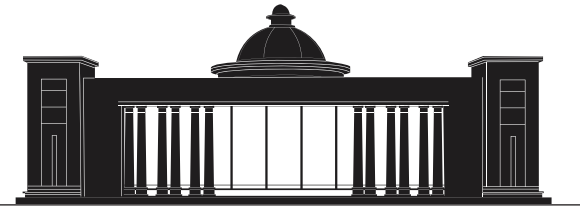
party plot on which the gaming zone was functioning," he added.

Ashoksinh and Kiritsinh Jadeja are owners of the party plot on which the gaming zone had been set up; and partners in Raceway Enterprise, apart from Yuvrajsinh Solanki and Rahul Rathod who were arrested earlier. Dhaval Thakkar, who was arrested on Tuesday, is the proprietor of Dhaval Corporation. DCP Gohil said Thakkar and Hiran were the key people in deciding the affairs of TRP Game Zone.

The game zone was set up at the JPS Party Lawns and two other adjacent party plots on the posh Nana Mava Road of Rajkot. The indoor gaming facilities had been developed in a tin shed supported by steel frames.

According to police, the shed had a ground floor and a first floor but the structure was as tall as a three-storey building, 50 metres wide and 60 metres long.

## No To CELEBRATION

WITH THE ruling BJP in the state under media scanner following the deaths of 28 people in the fire at the TRP Game Zone in Rajkot, the party's Rajkot city unit president Mukesh Doshi called a press conference to announce that as a respect for those who died in the blaze, the party will not celebrate in the city if BJP emerges victorious on June 4, the day results of Lok Sabha elections are to be announced. Union Minister Parshottam Rupala, who is BJP's candidate for the Rajkot Lok Sabha seat, Rajya Sabha member Ram Mokariya who lives in the city and Mayor Nayna Pedhadiya were also present at the press conference. However, none of them responded to questions that asked whether BJP will take action against any of its leaders holding offices in Rajkot Municipal Corporation in the aftermath of the fire incident.

## TRIBAL TRADITION

VETERAN CONGRESS leader Sukhrum Rathwa, who is contesting the Lok Sabha poll from Chhotu Udepur, on Wednesday "applauded the courage" of a relative of five victims of Rajkot's TRP Game Zone fire incident for publicly saying that he would "kill the accused if they are granted bail". Raising questions on the inaction and negligence of the administration, Rathwa said the kin of the victims had "spoken about meting out punishment the tribal way", as the administration had "failed" to do its job. "From Takshashila Arcade fire in Surat to Harmi Boat tragedy and even the Morbi bridge collapse, such incidents occurred because the persons responsible ignored safety precautions. These incidents, including Rajkot, are man-made massacres," Rathwa said. "My friend (Rajkot victims' kin) said that he would kill the accused if the courts grant them bail. It is our tribal tradition, if someone is killed in our family, we kill the perpetrator in return... I am not encouraging him but I applaud his courage. If the government had taken adequate steps, a civilian would not say that or be compelled to do such a thing," he added.
