Subject: Update on Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

This is with reference to our letter dated April 11, 2024, wherein the Company had informed the stock exchanges regarding receipt of an Order, from the Additional Commissioner, Customs & Central Tax, Hyderabad GST Commissionerate, Hyderabad raising a GST demand of ₹ 1,47,86,059/- and penalty of ₹ 14,78,606/- for FY2018-19 under Section 73 of the Central Goods and Services Tax Act, 2017 (“the Act”). The Company had subsequently filed an appeal against the said Order. The Department also filed an appeal against the relief of tax demand of ₹ 1,81,97,223/- granted to the Company vide the said Order.

In this regard, please note that the Company has received Order from the Commissioner of Customs & Central Tax (Appeals-I), Hyderabad (Commissioner Appeals-I) on September 1, 2026 at 6:32 p.m., wherein the appeal filed by the Department was allowed. The Company has also received Order from the Commissioner Appeals-I on September 2, 2026 at 12:52 p.m., wherein the appeal filed by the Company was rejected. This resulted in aggregate GST demand of ₹ 3,29,83,282/- and penalty of ₹ 14,78,606/- for FY2018-19. The Company would pursue an appeal / evaluate any other legal options against the aforesaid Orders, including filing of writ petition. The requisite details of the aforesaid Orders are enclosed herewith as **Annexure 1**.
