Subject: Update on Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

We refer to our intimation dated August 28, 2024, wherein the Company had informed the stock exchanges regarding receipt of an order from the Office of the Assistant commissioner, Central GST & Central Excise, Division -II, Guwahati-01, raising a GST demand of ₹ 29,07,652/-, Interest of ₹ 5,753/- and levying penalty of ₹ 2,90,766/- for the period April 2019 to March 2020. Subsequently, the Company filed an appeal against the said Order.

The Company has received an order from the Office of the Commissioner (Appeals) CGST, Central Excise & customs, Guwahati (“Order”) on Saturday, August 16, 2025 at 3:30 p.m., with revised GST demand of ₹ 26,58,640/-, Interest of ₹ 5,753/- and Penalty of ₹ 2,65,864/-. The Company would pursue an appeal / evaluate other legal options against the said Order. The requisite details of the said Order are enclosed herewith as an **Annexure 1**.

The Company has received aforesaid Order in hard copy at its Guwahati branch office on Saturday, August 16, 2025. The branch office has communicated the order to the concerned person at the Registered Office of the Company on Monday, August 18, 2025 at 10:41 a.m., being the first working day after receipt of the Order.
