Subject: Update on Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

We refer to our intimation dated May 1, 2024 wherein the Company had informed the stock exchanges regarding receipt of an Order from the Joint Commissioner, CGST & Central Excise, Bhopal, Madhya Pradesh raising a GST demand of ₹ 90,792,716/-, interest of ₹ 1,154,037/- and levying penalty of ₹ 9,129,271/- for the period April 2018 to March 2021. Subsequently, the Company filed an appeal against the said Order.

In this regard, please note that the Company has received an Order from Office of the Commissioner (Appeals), CGST & Central Excise, Bhopal, Madhya Pradesh ("Order") on December 18, 2025 at 6:34 p.m. with revised GST demand of ₹ 87,607,880/-, Interest of ₹ 1,154,037/- along with applicable interest under Section 50(3) of the CGST Act, 2017 read with the corresponding provisions of the SGST Act, 2017 & IGST Act, 2017 and Penalty of ₹ 8,777,337/-. The Company would pursue an appeal / evaluate any other legal options against the said Order including filing of writ petition. The requisite details of the said Order are enclosed herewith as an **Annexure 1**.

We further state and declare that the information and details provided in **Annexure 1**, in compliance with Regulation 30(13) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with the Industry Standards Note on Regulation 30 are true, correct and complete to the best of our knowledge and belief.
