Subject: Update on Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

We refer to our intimation dated January 30, 2025, wherein the Company had informed stock exchanges regarding receipt of an order from the Additional Commissioner of CGST & Central Excise, Palghar Commissionerate ('the impugned order'), raising a GST demand of ₹ 31,18,41,716/- under Section 74 of the Central Goods and Services Tax Act, 2017 ('the Act') along with interest under Section 50 and levying a penalty of ₹ 31,18,41,716/- under Section 74 read with Section 122 of the Act for the period July 2017 to March 2024 covering various states. Subsequently, the Company had filed a writ petition before Hon'ble Bombay High Court ("Hon'ble Court") against the impugned order. The impugned order refers to matters, which are relating to industry wide issues and pertains to applicability of GST on supplies of Group Health Insurance/ Group Personal Accident policies to units located within a Special Economic Zone.

In this regard, we wish to inform you that the Company has received an order dated March 26, 2026, from its tax advisors on March 28, 2026 at 10:46 p.m., passed by the Hon'ble Court, granting a stay on the impugned order till the final disposal of the Writ Petition.

The requisite details of the said Order are enclosed herewith as an **Annexure 1**.

We further state and declare that the information and details provided in Annexure 1, in compliance with Regulation 30(13) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with the Industry Standards Note on Regulation 30 are true, correct and complete to the best of our knowledge and belief.
