Subject: Update on Disclosure under Regulation 30 and Regulation 51 read with Schedule III of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI Listing Regulations)

We refer to our letter dated December 22, 2023, with respect to an order passed under Section 73 of Andhra Pradesh Goods and Service Tax Act, 2017 by Deputy Commissioner (State Tax), Andhra Pradesh, for FY2018.

Subsequently, the Company filed an appeal before the Commissioner (Appeals). In this regard, please be informed that the Company has received a common appeal order from Additional Commissioner of State Tax, Appellate Authority, Vijayawada, on December 2, 2025 at 11.50 a.m., wherein one of the appeals having total demand of ₹ 3,54,969/- is completely set aside and order is passed in favour of the Company. Further, the other appeal petition having total demand of ₹ 6,24,835/- is partially allowed in favour of the Company. Accordingly, partial demand to the extent of ₹ 4,59,386/- is dismissed and partial demand to the extent of ₹ 1,65,449/- is upheld.

The disclosure as required under Regulation 30(13) of the SEBI Listing Regulations read with the Industry Standards Note on Regulation 30 of the SEBI Listing Regulations are enclosed herewith as an Annexure A.
