- b. for any payment including dividend, interest or redemption payment in respect of such folios, only through electronic mode with effect from April 01, 2024.

- b. Through electronic mode: The documents may be furnished electronically from your registered e-mail id (in case of joint holder, by first joint holder) to inward.ris@kfintech.com
- c. Through web-portal of our RTA, KFin Technologies Limited: The documents with E-Sign may be furnished through service portal of RTA- <https://ris.kfintech.com>

On the service portal of RTA, you are required to register/signup, using the Name, PAN, Mobile number and email ID. Post registration, you can login via OTP and execute activities like, raising Service Request / Query / Complaints, check for status, KYC details, Dividend etc.

E-Sign is an integrated service which facilitates issuing a Digital Signature Certificate and performing signing of requested data by e-Sign user. The holder/claimant may approach any of the empanelled e-Sign Service Providers, details of which are available on the website of Controller of Certifying Authorities (CCA), Ministry of Communications and Information Technology (<https://cca.gov.in/>) for the purpose of obtaining an e-sign.

- d. Through 'In Person Verification' (IPV): The authorized person of the RTA shall verify the original documents furnished and retain copy(ies) with IPV stamping with date and initials.

Further, as per the Master Circular, with effect from April 1, 2024, any payment including dividend, interest or redemption payment in respect of physical folios shall be made only through electronic mode. Kindly dematerialise your securities held in physical form in order to avail various benefits of dematerialization.
