अंबरनाथच्या कचरा संकलनात कोट्यवधींच्या गैरव्यवहाराचा आरोप

नाल्यातील गाळ, चिखलाचे वजन करून बिले वाढवल्याचा दावा ; स्वतंत्र चौकशीची भाजप नगरसेवकांची मागणी

अंबरनाथ, दि. १३ (वार्ताहर) : अंबरनाथ शहरातील कचरा संकलनाच्या कामात कोट्यवधी रुपयांच्या आर्थिक गैरव्यवहाराचा गंभीर आरोप भाजप नगरसेवकांनी केला आहे. घरगुती कचऱ्याऐवजी नाल्यातील गाळ, चिखल आणि माती डंपरमध्ये भरून त्याचे वजन करण्यात येत असून, कुत्रिमरीत्या वजन वाढवून लाखो रुपयांची अतिरिक्त बिले उभारली जात असल्याचा दावा नगरसेवकांनी केला आहे. या आरोपांमुळे शहरातील कचरा व्यवस्थापन पुन्हा एकदा वादाच्या भोवऱ्यात सापडले असून, संपूर्ण प्रकरणाची निष्पक्ष चौकशी करण्याची मागणी जोर धरू लागली आहे.

अंबरनाथ शहरातील कचरा संकलनाचा ठेका २०२३ पासून समीक्षा कंपनीकडे असून, यापूर्वी २०१७ पासूनही हीच कंपनी हे काम करत आहे. सात ते आठ वर्षे काम करूनही शहरातील २१० हून अधिक कचराकुंड्या अद्याप कायम असल्याचा आरोप नगरसेवकांनी केला आहे. स्वच्छता व्यवस्थेत अपेक्षित सुधारणा न होता सार्वजनिक निधीचा अपय्य होत असल्याचा आरोप करत नगरसेवकांनी कचरा वाहतुकीच्या प्रक्रियेवर गंभीर प्रश्नचिन्ह उपस्थित केले



आहे. त्यांच्या म्हणण्यानुसार, कचरा वाहून नेणाऱ्या वाहनांमध्ये घरगुती कचऱ्याऐवजी नाल्यातील गाळ, चिखल आणि जड माती भरून ती खासगी वजनकाट्यावर नेली जाते. त्यामुळे वाहनांचे वजन कुत्रिमरीत्या वाढते आणि त्याआधारे अधिक रकमेची बिले तयार केली जातात.

नगरसेवकांनी प्रत्यक्ष खासगी वजनकाट्यावर जाऊन पाहणी केल्याचा दावा केला असून, समीक्षा कंपनीच्या वाहनांसोबत इतर खासगी डंपरचाही वापर होत असल्याचे त्यांनी सांगितले. रिकाम्या वाहनाचे वजन नियमितपणे घेतले जाते का, असा प्रश्न विचारल्यानंतर वजनकाटा चालकाने “जे वजन सांगितले जाते तेच नोंदवतो,” असे उत्तर दिल्याचा आरोपही

त्यांनी केला आहे. अंबरनाथमध्ये दररोज सुमारे १७० टन कचरा उचलला जात असल्याचा दावा केला जात असताना, कोटसंख्या आणि क्षेत्रफळाने मोठ्या बदलापूर शहरात अथवा १०० टन कचरा निर्माण होत असल्याने इतक्या मोठ्या प्रमाणात कचरा कास निर्माण होतो, असा सवाल भाजप नगरसेवक अभिजित करंजुळे पाटील यांनी उपस्थित केला आहे.

स्मार्ट मीटरमध्ये ‘कॅमेरा’ असल्याचा दावा खोटा; दोघांविरुद्ध गुन्हे दाखल

मुंबई, दि. १३ (प्रतिनिधी) : महावितरणच्या स्मार्ट मीटरमध्ये ‘कॅमेरा’ असल्याचा खोटा आरोप करून समाजाभ्यंमार्गे दिशाभूल करणारी माहिती प्रसारित केल्याप्रकरणी सिंधुदुर्ग जिल्ह्यातील ग्राहक संघटनेचे प्रतिनिधी नंदन मेघशरम वेंगुलेंकर आणि ‘कोकणसाद’ या यूट्यूब वृत्तवाहिनीचे संपादक सागर चव्हाण यांच्याविरुद्ध सावंतवाडी पोलीस ठाण्यात फौजदारी गुन्हे दाखल करण्यात आले आहेत. या अफवांमुळे नागरिकांमध्ये भीती व संभ्रमाचे वातावरण निर्माण झाल्याची गंभीर दखल घेत महावितरणने ही कारवाई केली असून, स्मार्ट मीटरबाबत कोणत्याही अप्रमाणित माहितीवर विश्वास ठेवू नये, असे आवाहनही करण्यात आले आहे.

या चर्चासत्रात महावितरणचे उपकार्यकारी अभियंता योगेंद्र वाघ, ग्राहक संघटनेचे नंदन वेंगुलेंकर आणि दीपक पटेकर सहभागी झाले होते. यावेळी महावितरणकडून स्मार्ट मीटरची कार्यपद्धती, त्याचे फायदे आणि विविध आरोपांबाबत सविस्तर खुलासे करण्यात आले. मात्र, चर्चेदरम्यान नंदन वेंगुलेंकर यांनी स्मार्ट मीटरमध्ये ‘कॅमेरा’ असल्याचा दावा करत नागरिकांच्या खासगी आयुष्यावर पाळत ठेवली जात असल्याचा आरोप केला. महावितरणच्या अधिकाऱ्यांनी त्याचवेळी या दाव्याचे खंडन करून वस्तुस्थिती स्पष्ट केली होती.

महावितरणच्या म्हणण्यानुसार, त्यानंतर ‘कोकणसाद’ यूट्यूब वृत्तवाहिनीने चर्चासत्रातील स्पष्टीकरणाचा भाग वाळून केवळ वादग्रस्त विधानांचा दोन ते तीन

मिनिटांचा व्हिडिओ ‘स्मार्ट मीटरची चिरफाड’ या शीर्षकाखाली विविध समाजाभ्यंमांवर प्रसिद्ध केला. या प्रकरणी जनतेमध्ये भीती निर्माण करणे, शांततेचा भंग होईल अशी परिस्थिती निर्माण करणे, बदनामी करणे आणि गुन्हास प्रवृत्त करण्यासंबंधी भारतीय न्याय संहितेतील कलम ३५३ (१)(ब), ३५१ (३), ३५२ आणि ३५६ अन्वये दोघांविरुद्ध सावंतवाडी पोलीस ठाण्यात गुन्हे नोंविण्यात आला असून पोलीस पुढील तपास करीत आहेत.
