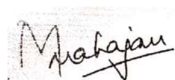

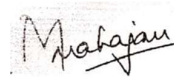

As against the proposed utilisation timeline indicated in the Offer Document, utilisation towards the crane manufacturing expansion project stood at Rs.25.40 crore as on June 30, 2026, against the total allocation of Rs.70.07 crore. Management has represented that the implementation schedule has been impacted by Land development & construction-related activities beyond the control of management; however, the company continues to pursue the project, and no cost overrun has been reported as on the date of this report. The Monitoring Agency has not observed any diversion of funds, and the unutilised proceeds continue to remain invested in permitted instruments.

Due to high demand & to cater the market, they have increased the installed capacity from 720 units to 1,280 units during the Fiscal 2024. The proportionate installed capacity for the Fiscal 2024 is 970 units. As on September 30, 2024, They had installed capacity 1280 units per annum.
