# चंडीगढ़ में स्कूलों व मुख्यमंत्री कार्यालय को उड़ाने की धमकी

ईमेल में अंबाला से दिल्ली रेल पटरी पर धमाके करने की चेतावनी

चंडीगढ़, 21 मई (ब्यूरो)।

चंडीगढ़ में कई स्कूलों और हरियाणा के मुख्यमंत्री कार्यालय को बम से उड़ाने की धमकी मिली है। पहले के मामलों की तरह इस बार भी धमकी ईमेल के माध्यम से आई है। ई-मेल में कहा गया कि एक बजे स्कूलों में और शाम 3:11 बजे हरियाणा के मुख्यमंत्री कार्यालय में धमाके किए जाएंगे।

धमकी मिलने के बाद स्कूल प्रबंधन ने तुरंत पुलिस को सूचना दी। इसके बाद पुलिस टीमों ने स्कूलों की जांच करवाई। हालांकि जांच में यह धमकी फर्जी साबित हुई। इससे पहले भी चंडीगढ़, हरियाणा व पंजाब में इसी प्रकार के धमकी भरे ईमेल मिल चुके हैं।

गुरुवार को भेजे गए ईमेल में कुछ आपत्तिजनक और भड़काऊ संदेश भी लिखे गए हैं। इसमें छह जून 2026 तक अंबाला से दिल्ली रेल पटरी पर आईडीडी धमाकों की धमकी का भी जिक्र किया गया है। जानकारी के अनुसार, यह धमकी भरा ईमेल कई स्कूलों

को भेजा गया था जिन स्कूलों को धमकी मिली उनमें सेक्रेड हार्ट स्कूल, संत कबीर स्कूल, भवन विद्यालय, सेंट स्टीफंस स्कूल सेक्टर-45, सेंट जोस स्कूल सेक्टर-26, चितकारा इंटरनेशनल स्कूल सेक्टर-25 और बीपीएस स्कूल सेक्टर-40 शामिल हैं। धमकी मिलने के बाद संबंधित स्कूलों में सुरक्षा व्यवस्था बढ़ा दी गई। जांच में फिलहाल किसी भी स्कूल से

कोई संदिग्ध वस्तु बरामद नहीं हुई है। चंडीगढ़ पुलिस का साइबर प्रकोष्ठ ईमेल की उत्पत्ति और भेजने वाले की पहचान करने में जुटा है। सुरक्षा एजेंसियां मामले को गंभीरता से लेते हुए सभी पहलुओं की जांच कर रही हैं। वहीं, प्रशासन ने अधिभावकों और लोगों से अफवाहों से बचने और शांति बनाए रखने की अपील की है।

## पंजाब पुलिस की जांच में खुलासा बचपन का दोस्त ही निकला एमबीबीएस छात्र का हत्यारा

चंडीगढ़, 21 मई (ब्यूरो)।

पटियाला में सरकारी मेडिकल कालेज के अंतिम वर्ष के एक छात्र की हत्या के मामले को पुलिस ने मुख्य आरोपी को गिरफ्तार कर लिया है, जोकि मृतक का बचपन का दोस्त निकला।

पुलिस अधिकारियों ने बताया कि एमबीबीएस कर रहे कमलदीप मित्तल का शव सोमवार को मिला था। वह न्यू लाल बाग कालोनी में स्थित किराए के कमरे में रहता था। पटियाला के वरिष्ठ पुलिस अधीक्षक वरुण शर्मा ने बताया कि

कमलदीप मित्तल की हत्या उसके बचपन के दोस्त मोहित वर्मा ने ही की थी। रविवार की रात दोनों कमरे पर एक साथ थे। सोमवार की सुबह जब कमलदीप शौचालय जाने लगा तभी मोहित ने पीछे से उस पर हमला कर दिया। वारदात के बाद मोहित ने कथित तौर पर कमलदीप के बैंक खाते से 2.5 लाख रुपए अपने खाते में डाल लिए। कमलदीप मोहित से शेर बाजार में निवेश किए गए अपने पैसे के बदले करीब चार लाख रुपए मांग रहा था, लेकिन मोहित उसे पैसे वापस नहीं कर रहा था।

हरियाणा में हालही में हुए बैंक चोटाले में सीबीआइ ने जांच के आधार पर पहला आरोपपत्र दाखिल कर दिया है। जांच एजेंसी ने संकेत दिए हैं कि जल्द ही अतिरिक्त आरोपपत्र भी दाखिल किए जाएंगे।

यह मामला शुरुआत में हरियाणा राज्य सतर्कता एवं भ्रष्टाचार निरोधक ब्यूरो की ओर से दर्ज किया गया था, जिसे बाद में जांच के लिए सीबीआइ को सौंप दिया गया। आईडीएफसी फर्स्ट बैंक व एयू स्माल फाइनेंस बैंक चोटाले की जांच हरियाणा

## बैंक चोटाले में सीबीआइ ने दाखिल किया पहला आरोपपत्र

चंडीगढ़, 21 मई (जनसत्ता)।

सरकार की तरफ से सीबीआइ को सौंपी गई थी। सीबीआइ जांच के दौरान कई आईएस अधिकारियों से पूछताछ हो चुकी है। हरियाणा इस मामले में करीब दो आईएस समेत कई अधिकारियों के विरुद्ध कार्रवाई भी कर चुकी है।

सीबीआइ की ओर से पंचकूला कोर्ट में दाखिल आरोपपत्र में कुल 15 आरोपियों को नामजद किया गया है। इनमें बैंक के छह अधिकारी, हरियाणा सरकार के तीन कर्मी, दो फर्जी कंपनियों व उनके तीन साझेदार/निदेशकों सहित तथा एक निजी व्यक्ति को शामिल किया गया है।

## पंजाबी विवि के छात्रावास के कमरे में मृत मिला छात्र

चंडीगढ़, 21 मई (ब्यूरो)।

पटियाला में पंजाबी विश्वविद्यालय के परिसर में स्थित छात्रावास के एक कमरे में बी टेक का एक छात्र मृत पाया गया है। पुलिस के अनुसार, मृतक की पहचान तरनतारन जिले के पिंग कांग गांव के निवासी वरुण प्रीत सिंह के रूप में हुई है।

बताया जा रहा है कि वरुण का शव छात्रावास के एक कमरे में बेसुध हालत में पड़ा मिला। इस मामले में सबसे ज्यादा हैरान

विश्वविद्यालय के बाहर एक पीजी में रहकर पढ़ाई कर रहा था वरुण प्रीत सिंह।

करने वाली और संदिग्ध बात यह है कि वरुण विश्वविद्यालय के छात्रावास में नहीं रहता था। वह परिसर के बाहर एक पीजी (पेइंग गेस्ट) में रहकर अपनी पढ़ाई कर रहा था।

पुलिस ने बताया कि यह घटना बुधवार देर रात उस समय सामने आई जब एक अन्य छात्र अपना कुछ निजी सामान लेने के लिए प्रीत सिंह के कमरे में गया था। छात्र के कमरे

में प्रवेश करने पर सिंह बेसुध हालत में पड़ा मिला। इसके बाद विश्वविद्यालय के सुरक्षाकर्मियों को तुरंत घटना की सूचना दी गई तथा परिसर के स्वास्थ्य केंद्र से एक मेडिकल टीम को मौके पर पहुंची। हालांकि, जांच के बाद चिकित्सकों ने उसे मृत घोषित कर दिया।

छात्रावास के प्रशासन प्रमुख ने कहा, 'शव को पोस्टमार्टम के लिए भेज दिया गया है और मौत के सटीक कारणों का पता रिपोर्ट आने के बाद ही चल पाएगा।'

## 'काकरोच जनता पार्टी' आज रोहतक में करेगी प्रदर्शन

चंडीगढ़, 21 मई (ब्यूरो)।

हाल ही में अस्तित्व में आई 'काकरोच जनता पार्टी' के बैनर तले रोहतक में शुक्रवार को युवाओं का एक विरोध-प्रदर्शन होने जा रहे हैं।

रोहतक जिला परिषद सदस्य जयदेव डगर ने बताया कि इस प्रदर्शन का मकसद स्कूल की इमारतों की कमी, खराब खेल

संरचनाओं व नीट परीक्षा के पेपर लीक जैसे मुद्दों को उजागर करना है। डगर ने बताया कि युवा सुबह दस बजे मानसरोवर पार्क में इकट्ठा होंगे और इसके बाद वे लगभग 300 मीटर दूर स्थित उपायुक्त के कार्यालय तक रैली निकालेंगे। उन्होंने कहा कि वह उन लोगों के साथ खुद को जोड़कर देखते हैं जिन्हें 'काकरोच' कहा गया है।

हरियाणा में 15 जून से मतदाता सूचियों का विशेष गहन पुनरीक्षण (एसआइआर) शुरू होगा। मुख्य निर्वाचन अधिकारी ए श्रीनिवास ने गुरुवार को चंडीगढ़ में बताया कि मतदाता सूचियों का यह विशेष गहन पुनरीक्षण 15 जून से 14 जुलाई तक होने जा रहा है और मतदाता सूची का अंतिम प्रकाशन 22 सितंबर को किया जाएगा।

मुख्य निर्वाचन अधिकारी ने कहा कि अन्य राज्यों की तुलना में हरियाणा के चुनावी ब्योरे में

राज्य के 37 लाख मतदाताओं के ब्योरे में गड़बड़ी।

लगभग 18 फीसद (करीब 37 लाख) तार्किक त्रुटियां हैं, जिनमें गलत नाम और वर्तनी की गलतियां शामिल हैं।

अब तक मुख्य निर्वाचन अधिकारी कार्यालय को 14,520 बीएलए का विवरण प्राप्त हुआ है, जिनमें भाजपा से 6,438, कांग्रेस से 7,704, माकपा से 165 और बाकी अन्य राजनीतिक दलों के हैं। बीएलए भी गणना प्रपत्र एकत्र कर बीएलओ को सौंप सकते हैं।
