DEEPENING COOPERATION

Partnership with India at a totally new level: EU envoy

Says PM's 'not an era of war' message resonates with EU

New Delhi, May 9

THE EUROPEAN UNION-India partnership is "limitless, ambitious and progressive" and both sides have elevated the relationship to a "totally new level" in both qualitative and strategic terms, EU Ambassador Herve Delphin has said.

In an address at an event, the envoy also noted that Prime Minister Narendra Modi's "not an era of war" message "deeply resonates" with Europe's values and identity, and called the EU "fundamentally a peace project".

Characterising the EU-India summit held three and a half months ago as a milestone, Delphin said the confluence of symbolism, substance and strategic significance resulted in "momentous out-

comes". "We have placed our relationship to a totally new level, in qualitative and strategic terms. The EU-India partnership is limitless, ambitious and progressive," he said.

"These achievements would not have been possible without the political conviction and trust shared by our leaders," the envoy said at the Europe Day celebrations on Friday night. Delphin cited the unveiling of a joint strategic agenda for the next five years, the conclusion of negotiations for an ambitious free trade

agreement, the signing of a security and defence partnership pact and the firming up of a comprehensive framework on mobility as major take-aways from the summit.

"Fundamentally, we are global forces for good. We are both recognised as trusted, reliable partners working for global stability and prosperity, promoting global cooperation and solutions," he said.

"That India and the EU and its member states are deepening their ties like never before is truly a reason for celebration

this year. This is the Europe-India moment," Delphin said in the presence of Finance Minister Nirmala Sitharaman and a sizeable number of diplomats, academicians and foreign policy experts. The envoy characterised the presence of European Commission President Ursula von der Leyen and European Council President Antonio Costa as the Chief Guests at India's Republic Day parade and the EU-India summit as a "moment where symbolism, substance and strategic significance came together, resulting in momentous outcomes".

The FTA between the two sides has been billed as the "mother of all" trade deals.

"We are already India's leading trading partner. With the FTA, we expect our two-way trade to double in value in the next years," Delphin said. The envoy also cited a report titled the "EU business economic footprint in India" released this week that analysed various dimensions of the two-way economic engagement.

While Chinese exporters have so far weathered the fall-out from the conflicts, economists warn that the longer the war drags on and energy prices rise, the greater the risk that external demand fades away, leaving sluggish domestic consumption unable to plug the gap. "There is still room for expansion in this round of manufacturing cycle driven by AI, and it is expected that the annual export growth rate will be about 10%," say experts.

China April exports up ahead of Trump visit

CHINA'S EXPORT GROWTH gathered pace in April as factories raced to meet a wave of orders from AI-related industries and other buyers seeking to stockpile components amid fears the Iran war could push global input costs even higher.

That export strength, which has seen China's trade surplus with the US widen to \$87.7 billion so far this year, will be in focus next week as President Donald Trump travels to Beijing for a leaders' summit expected to extend last year's trade truce.

While Chinese exporters have so far weathered the fall-out from the conflicts, economists warn that the longer the war drags on and energy prices rise, the greater the risk that external demand fades away, leaving sluggish domestic consumption unable to plug the gap. "There is still room for expansion in this round of manufacturing cycle driven by AI, and it is expected that the annual export growth rate will be about 10%," say experts.

SHOW-CAUSE NOTICE BY WRESTLING FEDERATION

Vinesh stopped from competing till June 26

THE WRESTLING FEDERATION of India (WFI) has issued a 15-page show-cause notice to wrestler Vinesh Phogat, accusing her of indiscipline, violations of anti-doping regulations, and breaches of United World Wrestling (UWW) rules.

The federation has also barred her from competing in domestic events until June 26, effectively delaying her planned return to competitive wrestling. The suspension from domestic competition is also likely to derail her hopes of making a comeback in time for major international events, including the Asian Games cycle leading up to the 2028 Los Angeles Olympics.

The notice, issued Saturday, comes nearly two years after Vinesh announced her retirement following her disqualification on the morning of the 2024 Paris Olympics final.

Earlier this year, the former world championship medalist had indicated her intention to return to the sport and was targeting the National Open Ranking tournament

in Gonda in UP, scheduled to begin this Sunday. Gonda is the home turf of former WFI chief Brij Bhushan Sharan Singh, a former MP, who was accused of sexual harassment by six women wrestlers. On May 3, Vinesh said she was one of the six who had complained against him.

According to the WFI, Vinesh failed to comply with the mandatory six-month notice period required under the UWW

Anti-Doping Rules for athletes returning from retirement. The federation has asked her to respond to the allegations within 14 days.

A major portion of the notice relates to Vinesh's controversial disqualification from the Paris Olympics, where she competed in the women's 50kg category. Vinesh had scripted history by becoming the first Indian woman wrestler to reach an Olympic final. However, she was disqualified ahead of the gold medal bout after failing the second-day weigh-in by 100 grams.

In the notice, WFI alleged that her decision to cut down from her natural weight category and subsequent failure to maintain the required limit caused significant damage to Indian wrestling's reputation. The notice also raises concerns over alleged anti-doping rule violations linked to missed whereabouts filings and unsuccessful dope-control attempts. Under international anti-doping regulations, an athlete can face suspension of up to two years if found guilty of three whereabouts failures in 12 months.



Nations to evacuate citizens from hantavirus-hit cruise

GERMANY, FRANCE, BELGIUM, Ireland, and the Netherlands will send planes to evacuate their citizens aboard the Tenerife-bound cruise ship hit by a deadly hantavirus outbreak, Spain's interior minister said in Madrid on Saturday.

The European Union is sending two further planes for remaining European citizens, Fernando Grande-Marlaska added. The US and UK have confirmed planes and contingency plans were being arranged for non-EU citizens whose countries were unable to send air transport, he said. World Health Organization (WHO) Director-General Tedros Adhanom Ghebreyesus will meet Spain's Prime Minister Pedro Sanchez in

Madrid on Saturday afternoon and then travel to Tenerife in the Canary Islands, alongside Spain's interior and health ministers to coordinate the arrival of the ship.

Local authorities have warned the evacuation must

take place between Sunday midday and Monday afternoon before conditions at sea are expected to take a turn for the worse until the end of May due to stormy weather.

Wednesday from the coast of Cape Verde after the WHO and EU asked the country to manage the evacuation of passengers. WHO said on Friday that eight people had fallen ill, including three who died - a Dutch couple and a German national. Six of these people are confirmed to

have contracted the virus, with another two suspected cases, the WHO has said. The head of the WHO arrived in Spain on Saturday where he joined senior government officials in Tenerife to oversee the safe disembarkation of passengers.

WHO Director General, Tedros Adhanom Ghebreyesus said on X that he was in contact with the ship's captain and a WHO colleague who is on board who said that, at this stage, there are no additional people on board showing symptoms.

Hantavirus is usually spread by rodents but can in rare cases be transmitted person-to-person. All passengers as well as 17 crew members will be evacuated but 30 crew will stay on board and travel on to the Netherlands, Spain's Health Minister Monica Garcia said.

UK PM brings ex-premier Brown as finance envoy

BRITISH PRIME MINISTER Keir Starmer named former premier Gordon Brown as his envoy on global finance on Saturday, turning to a man credited with shoring up banks during the financial crisis to bolster his support after a crushing local elections defeat.

Starmer is on the back foot after his Labour Party recorded the worst losses of a governing party in municipal polls since 1995, prompting a growing number of his own lawmakers to call on him to quit.

Aiming to reset his leadership and win back party support, Starmer's office announced the appointment of two Labour grandees, Brown, 75, and Harriet Harman, also 75, to his team as advisers. Brown will seek to drive new investment and hone relations with the EU, in a bid to boost economic performance and win back votes, while Harman will focus on tackling misogyny and violence against women and girls, creating economic opportunities. Amid fresh calls for him to resign on Saturday from several of his own lawmakers, as the extent of the defeat emerged, Starmer repeated, "I'm not going to walk away from this." He said he will respond to the message from voters by seeking to convince them their lives will improve, adding that his new hires, Brown and Harman, were part of the plan.

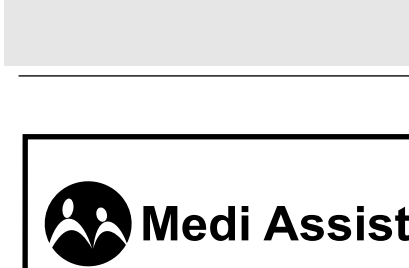
