The Board of Directors of **360 ONE WAM LIMITED** ("Company") vide its resolution passed on April 3, 2025, decided to conduct the process of voting through postal ballot for obtaining approval of shareholders of the Company for the request received from Part of Promoter Group Entities for reclassification from 'Promoter & Promoter Group' category to 'Public' category as more particularly set out in the postal ballot notice dated April 3, 2025.

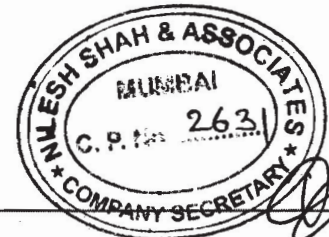
The Postal Ballot Notice dated April 3, 2025, along with the statement setting out material facts pursuant to Section 102 of the Companies Act, 2013 and Companies (Management and Administration) Rules, 2014, read with Listing Regulations, 2015, was sent to the shareholders of the Company, by electronic form only i.e. by email to all shareholders / beneficiaries whose names appeared in the Register of Members / Record of Depositories as on the cut-off date i.e. March 28, 2025, in accordance with the provisions of the Companies Act, 2013, read with Rules made thereunder and MCA Circulars.

For avoidance of any doubt, meaning of 'Postal Ballot' denotes only 'remote e-voting' for the purpose of this resolution.

The shareholders of the Company holding shares on the cut-off date of March 28, 2025, were entitled to vote on the resolution as set out in the postal ballot notice.

In this regard, we submit our report as under:

1. The Company had provided facility of casting vote to the shareholders of the Company through postal ballot voting process by remote e-voting only, on the platform provided by CDSL.
2. The Company had followed the process as required under Section 108 read with Section 110 of the Companies Act, 2013 and Rule 22 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, read with MCA Circulars and Listing Regulations, 2015, in respect of providing voting facility through postal ballot via electronic means.
3. The Postal Ballot voting (remote e-voting) period commenced from April 5, 2025, 9:00 a.m. and concluded on May 4, 2025, 5:00 p.m. and thereafter the e-voting module was disabled for voting.
4. At the end of the e-voting period, we unblocked the electronic votes in the presence of two witnesses not in the employment of the Company.
