In terms of Regulations 30 and 51 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, we wish to inform you that Fitch Ratings Singapore Pte Ltd. (**"Fitch"**), the credit rating agency, has withdrawn the 'B+' rating assigned to the USD 1 billion secured Medium Term Note Programme of IIFL Finance Limited (the **"Company"**) and has assigned B+/ Stable rating to the USD 1 billion Global Medium Term Note ("GMTN") Programme of the Company.
