SPECIAL WINDOW FOR TRANSFER AND DEMATERIALIZATION OF PHYSICAL SHARES

Securities and Exchange Board of India ("SEBI") had discontinued transfer of physical shares from 1st April, 2019. However, a Special Window was opened by SEBI from 7th July, 2025 to 6th January, 2026 for re-lodgement of physical share transfer requests originally submitted before 1st April, 2019 but returned / rejected / not attended due to deficiency in documents / process / otherwise.

To facilitate the investors, SEBI opened another Special Window for one year from 5th February, 2026 to 4th February, 2027. Eligibility to lodge transfer request under the specified Special Window is as follows:

Further, the following cases will not be considered under this window:

- (a) Cases involving disputes between transferor and transferee;
- (b) Securities which have been transferred to Investor Education and Protection Fund (IEPF).

Note: The shares re-lodged during this period will be processed through the transfer-cum-demat route i.e. they will only be issued in dematerialized (demat) form after transfer and the same will be subject to lock-in period of one year.
