5. The voting period for remote e-voting commenced on Wednesday, September 24, 2025 (09:00 hrs IST) and ended on Friday, September 26, 2025 (17:00 hrs IST). The remote e-voting module was disabled by NSDL for voting thereafter.
6. The Unsecured Creditors meeting was convened on Saturday, September 27, 2025 at 12:00 PM in accordance with the directions of the orders referred above through Webex. The quorum fixed for the meeting was 15 (Fifteen).
7. The Company has also provided e-voting facility for those Unsecured Creditors who had not cast their vote on the resolution earlier by availing the remote e-voting facility prior to the meeting.
