# **Subject: Revision in Benchmark Rates**

In terms of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we have to inform you that the Asset Liability Management Committee (ALCO) of the Bank has reviewed the Marginal Cost of funds based Lending Rate (MCLR), Treasury Bills Linked Lending Rates (TBLR), Base Rate and Benchmark Prime Lending Rate (BPLR) and decided for revision in TBLR as detailed below:

#### **TBLR**

| SI. No. | Tenor                 | Existing Rate (%) | Revised Rate (%) |
|---------|-----------------------|-------------------|------------------|
| 1       | <= 3 months           | 6.60%             | 6.45%            |
| 2       | >3 months &<=6 months | 6.65%             | 6.55%            |
| 3       | >6 months &<=1 year   | 6.65%             | 6.55%            |
| 4       | >1 year &<= 3 Years   | 6.65%             | 6.55%            |

The revised TBLR is effective from **03.11.2024**.
