RISING GEN Z INFLUENCE DRIVES HISTORIC POLITICAL CHANGE

Rapper-turned-politician sweeps historic Nepal polls

PRESS TRUST OF INDIA Kathmandu, March 8

THE RSP-LED by young rapper-turned-politician Balendra Shah 'Balen' on Sunday headed towards a spectacular victory with over two-thirds seats in general elections that saw the legacy parties face rout at the hustings in Nepal.

Formed in 2022, the Rashtriya Swatantra Party (RSP) won 122 of the 165 directly elected seats in the House of Representatives elections, according to the Election Commission (EC).

The EC has announced results for 159 of the 165 seats as of 8:30 pm.

Results for six seats remain to be declared, the EC said, adding, the counting that had started on Thursday soon after voting ended will conclude by Monday afternoon for direct seats.

On Saturday, RSP's 35-year-old prime-ministerial candidate Balen defeated four-time prime minister K P Sharma Oli, the chair of Nepal's one of the largest parties—CPN-UML—by a huge margin of about 50% votes in the Jhapa-5 constituency.

Balen is expected to be the next prime minister of Nepal, reflecting a public mood of rejection of established parties. He will be the first Madhesi prime minister of the Himalayan nation and also the

youngest to occupy the top post in the country's parliamentary history.

The Nepal Congress (NC) is a distant second, winning 17 seats while the CPN (UML) of ousted prime minister Oli won just eight seats and is leading in two constituencies.

The Nepal Communist Party (NCP) won seven seats, the Shram Sanskriti Party won three while the Rashtriya Prajatantra Party (RPP) won one seat, the EC data showed.

Among the winners is one independent candidate Malabir Pun, who had resigned as education minister of the interim government, won in

Myragdi-1 constituency in remote mountain districts beating his nearest rivals from the CPN (UML) and the NC. The RSP had not fielded any candidate against him.

The seats won by RSP, headed by Ravi Lamichhane, include a clean sweep of all 15 constituencies of three districts in Kathmandu Valley.

RSP chairman Lamichhane won with a huge margin from the Chitwan-2 constituency, marking his third consecutive victory, with 54,402 votes against his nearest rival, NC's Mina Kumari Kharel getting only 11,564 votes.

Former deputy speaker Indira Rana Magar, of the RSP,

won by a huge margin from Jhapa-2 by defeating the leader of the dissolved House of Representatives and senior leader of CPN-UML Dev Raj Ghimire.

Nepal Congress president Gagan Thapa, 49, who was projected as his party's prime ministerial candidate, lost from Dhanusha-4 constituency to Amaresh Singh of the RSP.

Other senior leaders of Nepal Congress, including general secretary Guru Raj Ghimire, Shekhar Koirala and Bimalendra Nidhi, also faced defeat.

Harka Rai, chairman of the Shram Sanskriti Party, won from Sunsari-1, defeating RSP candidate Goma Tamang.

OpenAI's robotics head resigns over Pentagon deal

THE HEAD OF OpenAI's robotics team resigned on Sunday, citing the company's deal to deploy its artificial intelligence (AI) models within the Pentagon's classified network as the cause.

"This wasn't an easy call," Caitlin Kalinowski wrote in a post on X.

"It has an important role in national security. But surveillance of Americans without judicial oversight and lethal autonomy without human authorization are lines that deserved more deliberation than they got."

OpenAI confirmed Kalinowski's departure in an email statement and said it believes the agreement with the Defense Department "creates a workable path for responsible national security uses of AI while making clear our red lines, no domestic surveillance and no autonomous weapons."

"We recognize that people have strong views about these issues and we will continue to engage in discussion with employees, government, civil society and communities around the world," the company said.

It could not immediately reach Kalinowski for comment, but she wrote on X that while she has "deep respect" for OpenAI CEO Sam Altman and the team, the company announced the Pentagon deal "without the guardrails defined," she posted.

"It's a governance concern first and foremost," Kalinowski wrote in a message on X post.

"These are too important for decisions or announcements to be rushed," she wrote. TechCrunch previously reported Kalinowski's resignation.

Kalinowski joined OpenAI in November 2024 as a member of the company's technical staff in robotics after leading development of augmented reality glasses for Meta, according to her LinkedIn profile.

China hails 'landmark' year in US ties

HOURS AFTER DONALD Trump threatened to expand strikes on Iran and his Beijing's strategic partner "very hard," China's top diplomat took the stage before the world's press and declared this could be a defining year for US-China ties.

"When the two sides treat each other with sincerity and good faith," Foreign Minister Wang Yi said, both powers could "make 2026 a landmark year of sound, steady and sustainable development of China-US relations."

The Sunday statement amounts to the clearest signal yet that Beijing intends to shield its relationship with Washington from the US-led attack despite maintaining an upgraded partnership with Tehran that Wang himself signed just five years ago.

President Donald Trump ordered all government departments to stop working with Anthropic, and the Pentagon declared the company and its products a supply-chain risk.

Anthropic, in turn, has said it would challenge the designation—which previously was reserved for entities of adversary nations such as China's Huawei—in court.

IT firms eye Soken's artificial intelligence model

"NOW WE ARE building a 120-billion parameter model which will support all Indian languages, including the 22 scheduled languages."

The company intends the model to serve as a base platform for applications built in India and across emerging markets. Upperal said Soken AI is

also open-sourcing parts of its datasets to encourage wider development.

A key use case the startup is targeting is coding, particularly for domestic large IT services industry. According to Upperal, several firms are exploring domestic AI models as an alternative to global offerings.

"We are seeing interest from IT companies for the AI model we're building for coding," he said. "Many of them want domestic models so that their data remains within the country and operates within defined guardrails."

Upperal added that demand is currently strongest

from government departments and public-sector entities, but private-sector interests are also rising.

Soken AI is in discussions with stakeholders in sectors such as defence, agriculture and financial services for potential deployments.

There are deals in the works

which will announce soon," he said, adding that AI models can have applications such as strategic analysis and real-time monitoring in defence. For now, the company is focusing on building a strong text-based foundational model before expanding to multi-modal capabilities.

"We are working on the brain first," Upperal said. "Once that is built, we can add the eyes and ears later. Multi-modality can be added later, but the base model needs to be strong." Upperal said the firm expects its coding model to achieve performance comparable to tools such as Anthropic's Claude Code.

LAUNCHED IN 2019 to provide functional household tap connections to all rural homes, the Jal Jeevan Mission has expanded coverage from about 17% of rural households to more than 80%. However, officials say the next phase must address weaknesses in implementation, including corruption, inflated contracting practices and a system that rewarded pipeline construction rather than assured water supply.

The total estimated outlay of the centrally sponsored scheme was ₹3.6 lakh crore, of which the Centre's share was ₹2.08 lakh crore and has largely been utilised up to FY25. The budget allocation of ₹67,000 crore for FY26 was reduced to ₹17,000 crore in the revised estimates amid concerns over corruption and poor service delivery.

And flows to states under the existing mechanism have slowed sharply, with only ₹31 crore released until February 12, 2026. JIM 2.0 is expected to drive spending under the ₹67,000 crore allocation proposed for FY27.

Under the current system, many rural water supply projects are implemented by state Public Health Engineering Departments (PHEDs) through contractors. Payments are typically linked to infrastructure creation—such as laying pipelines or installing connections—rather than verifying whether water actually reaches households. This has created incentives to complete projects on paper without ensuring a sustained supply. Officials say the revised framework will dismantle this model by linking fund releases to verified water delivery and by transferring operational responsibility to local governments. In the proposed scheme, single-village water supply schemes will become the responsibility of Gram Panchayats. Once infrastructure is created, assets will be handed over to the Panchayat, which will operate the system as a village-level "micro utility."

Operations and maintenance funds will flow directly to Panchayats instead of through contractors.

Renault Duster returns to...

KIA'S SELTOS, EVEN while transitioning to a new generation, still averaged about 5,500 units a month.

Further down the table, Honda's Elevate averaged about 1,800 units monthly, while Volkswagen's Taigun and Skoda's Kushaq posted averages of about 1,045 units and 680 units, respectively. New entrants include the quickly gaining traction. Maruti's recently launched Victor is already clocking close to 10,000 units monthly, while Tata Motors' revived Sierra has delivered around 10,000 units since launch and claims bookings of more than 70,000. The numbers illustrate how firmly entrenched the current leaders are—and the scale Renault will need to achieve if the Duster is to reclaim its place.

The powertrain landscape has also shifted dramatically since the Duster's earlier run. The new SUV will initially be offered with a 1.0-litre turbo-petrol engine and a 1.3-litre turbo-petrol unit. Later this year, Renault plans to introduce a 1.8-litre strong hybrid producing around 160 hp. Notably, however, the new Duster will not offer a diesel engine and



there are no plans for a CNG version at launch.

That puts it at a slight disadvantage against rivals offering a wider spread of options—from naturally aspirated petrol and turbo-petrol engines to diesel, CNG and hybrid powertrains. The fuel mix issue has evolved. Diesel once dominated mid-size SUVs with a 55.7% share in 2020, but that share is expected to fall to around 44.9% by 2025. Petrol engines initially gained ground, rising to nearly 49% in 2023, while electrified options are gradually reshaping the market. Strong hybrids account for around 4-5% of segment sales and CNG variants are emerging as a cost-conscious alternative.

Technology has become another crucial battleground. Market leaders such as the Hyundai Creta and Kia Seltos now offer large infotainment displays, digital instrument

clusters, connected-car technology and long lists of comfort features.

Safety expectations have also risen sharply, with six airbags, Level-2 ADAS systems, 360-degree cameras and advanced braking technologies increasingly becoming standard across the segment.

The India-specific Duster attempts to keep pace. It will come with six airbags as standard, Level-2 ADAS, a 360-degree camera, tyre-pressure monitoring and four-wheel disc brakes.

Inside, Renault is offering a 10.1-inch touchscreen infotainment system, a 10.25-inch digital instrument cluster, wireless charging, dual-zone climate control, ventilated and powered front seats, ambient lighting and a panoramic sunroof.

Yet some areas could still tilt in favour of rivals. Rear-seat comfort features such as sunshades, reclining seats and rear ventilation are missing.

What the Duster does offer is a more rugged stance—riding on up to 18-inch alloy wheels with 212 mm of ground clearance, positioning it as a tougher alternative to many urban-focused SUVs.

Iran warns it can continue...

ISRAEL SAID THE depots were legitimate military targets used to support Iran's war effort, including the storage of fuel for ballistic missile systems. Prime Minister Benjamin Netanyahu said Israel would press ahead "with all our force," promising further attacks as part of a broader campaign aimed at weakening Iran's leadership.

Iran condemns the strikes as a dangerous escalation. Foreign Ministry spokesman Esmail Baghai said targeted fuel depots releasing toxic materials into the air and amounted to a war crime that endangered civilians and the environment.

The attacks marked the first reported strikes on Iran's oil infrastructure since the

conflict began, fuelling concerns over global energy supplies. Oil prices have surged while stock markets have fallen as traders worry about disruptions to exports from the region.

The conflict has rapidly expanded beyond Iran and drone attacks have struck targets across West Asia, including fuel tanks at Kuwait's international airport and a desalination plant in Bahrain—facilities critical to water supplies in the desert region.

Saudi Arabia said it intercepted a wave of drones heading toward key sites in Riyadh, including the diplomatic quarter. The United Arab Emirates also reported intercepting most of the missiles and

drones launched toward its territory.

The strike on Kuwait's aviation fuel storage intensified fears over energy security. Kuwait's national oil company has already cut crude production amid threats to shipping through the Strait of Hormuz, the strategic waterway through which roughly a fifth of the world's oil and gas supplies pass.

The war has also spilled into Lebanon. Israel said it carried out a precision strike targeting commanders from the Quds Force—an overseas arm of Iran's Revolutionary Guard—at a seaside hotel in central Beirut.

Lebanon's health ministry said at least four people were killed in the strike.

कोलेजियम से अनुभव किया कि वह अपने विचार क्षेत्र को विस्तार करें और उच्चतम न्यायालय में वकालत करने की अनुमति-अनुमति वाली महिला अधिकारियों को परदेनिष्ठ के लिए शामिल करें। न्यायमूर्ति सुकांत ने कहा था कि यदि प्राप्ति को सार्थक बनाया है, तो उसे संरक्षण रूप देना होगा। उन्होंने कहा कि कहां-कहां नहीं होनी चाहिए कि किसी एक व्यक्ति को अधिक प्रतिनिधित्व मिला, बल्कि वह शोनी चाहिए कि उच्चतम न्यायालय और देवा पर के उच्च न्यायालयों ने समाज-सुधारक निश्चयता को अपनी प्रक्रियाओं में समाहित किया। शुद्ध यौन इन ला नामक संगठन से जुड़ी चर्चा अधिकारी शोभा गुप्ता और महालक्ष्मी पार्वती ने अधिकारियों का स्वागत किया। अधिकारियों में पूर्व प्रधान न्यायाधीश पार्वती रमण और सुप्रीम कोर्ट के अन्य सेवानिवृत्त न्यायाधीश शामिल थे, जिन्होंने न्यायमूर्ति शोभा नारायण और उच्च न्यायालय की शामिल थीं।
