This has with reference to your email dated 06.04.2025 “ Clarification for Financial results - INDLMETER -- Reminder - 301” w.r.t. financial results submitted on 13-Aug-2024 in the matter of IMP Powers Limited.

In this regard, we would like to inform you that IMP Powers Limited has been purchased as going concern under Regulation 32 (e) of IBBI (Liquidation Process) Regulations 2016 through an e-auction by Electrify Energy Private Limited in consortium with Shri Rakesh Ramanlal Shah.

Subsequently, in an application filed by the above-named successful auction purchaser, Hon’ble NCLT, Ahmedabad in IA 1387 (AHM) 2024 in CP (IB) 203 of 2020 vide its order dated 05.11.2024 allowed certain relief and concessions. Copy of the order is attached for your reference.

Reporting for which clarification is sought by exchange is done from the office of the liquidator and the said details of reporting is not made available to the new management hence the present management is unable to comment on the reporting made by the office of liquidator.

In the meanwhile we already requested the exchange vide our email dated 31.01.2025 for revocation of suspension on trading of shares and listing of new shares to be allotted as per the above cited order.
