B'desh polls in Dec-June: Yunus aide

DHAKA
Environment Adviser Syeda Rizwana Hasan on Friday said that the interim government did not take on the responsibility of running the country solely to conduct elections. "Following Thursday's meeting of the Advisory Council, we had extensive discussions. We have three critical responsibilities: reform, justice, and elections. We did not take on this responsibility merely to hold elections," Rizwana said while speaking to journalists after an event at the University of Dhaka. The adviser said: "The election will be held between December and June. There is no scope for it to be delayed by even a single day. Therefore, it would have been better not to make speculative comments about it."

Names of two moms in birth certs allowed

Italy's Constitutional Court ruled Thursday that two women can register as parents of a child on a birth certificate, saying recognition of parental rights can't be restricted to the biological mother alone in families with same-sex parents. The court ruled that it was unconstitutional for city registrars to deprive children born to same-sex parents of recognition by both the biological mother and the woman who consented to the medically assisted pregnancy of her partner and assumed parental responsibilities.

Harvard fights Trump govt for bar on foreign students

Harvard University sued the Trump administration on Friday over its decision to revoke the Ivy League school's ability to enroll foreign students, ratcheting up White House efforts to conform practices in academia to President Donald Trump's policies.

In a complaint filed in Boston federal court, Harvard called the revocation a "blatant violation" of the U.S. Constitution and other federal laws, and had an "immediate and devastating effect" on the university and more than 7,000 visa holders.

"With the stroke of a pen, the government has sought to erase a quarter of Harvard's student body, international students who contribute significantly to the University and its mission," Harvard said.

"Without its international students, Harvard is not Harvard," the 389-year-old school added.

Harvard asked a federal judge to block the revocation, citing "the immediate and irreparable harm inflicted by this lawless action." The case was assigned to U.S. District Judge Allison Burroughs.

White House spokesperson Abigail Jackson dismissed the lawsuit.

"If only Harvard cared this much about ending the scourge of anti-American, anti-Semitic, pro-terrorist agitators on their campus they wouldn't be in this situation to begin with," Jackson said.

FUTURE TENSE

WHO ARE AFFECTED?

● Harvard enrolls nearly **6,800 international students**, making up 27% of the alumni representing over 140 countries. Currently, **788 students** are from India.

● Students who completed their degrees this semester will be allowed to graduate. The changes would take effect for the 2025-2026 academic year. Harvard's Class of 2025 is expected to graduate next week.

● Students who are yet to complete their degree need to transfer to another university.

The Trump administration has told Harvard's foreign students that they must transfer to other schools or they will lose their legal permission to be in the US. They will now have to scramble to figure out their next steps.



What next?

Educational institutions are required to have Student and Exchange Visitor (SEVP) certification with US Immigration and Customs Enforcement in order to admit applicants who have an F-1 or M-1 student visa.

International students at institutions that have lost their SEVP certification are typically allowed to try to transfer to a different certified school before they must leave the country.

TAKING A TOLL

● Many students' post-graduation plans, including job offers and internships, hinge on visa status, which is now in jeopardy.

● The psychological stress of having plans disrupted — especially after years of effort and significant investment — is immense.

● Future international applicants may reconsider the US as a destination, leading to diminished cultural exchange and academic diversity.

'Unwanted, flagrant attack: South Asian student group slams order

A prominent South Asian student group at Harvard has "strongly condemned" the Trump administration's decision to revoke the university's eligibility to enroll foreign students, terming it an "unwarranted and flagrant attack" and calling on varsity's administration to maintain steadfast support for its international student community.

The Trump administration on Thursday ordered the Department of Homeland Security to terminate Harvard University's Student and Exchange Visitor Programme (SEVP) certification. "This means Harvard can no longer enroll foreign students and existing foreign students must transfer or lose their legal status," the federal agency said.

China bristles, says Trump action will harm US international standing

The Chinese government said Friday that the Trump administration's move to ban international students from Harvard would harm America's international standing, and one university in Hong Kong looked to capitalise on the uncertainty by promising to take them in.

Chinese students make up a large part of Harvard University's international student population. The university enrolled 6,703 international students across all of its schools in 2024, according to the school's data, with 1,203 of those coming from China. The Trump administration's move, announced Thursday, was a hot topic on Chinese social media.

Terror and mockery of due process, says released PIO scholar

One of the lowest moments of Badar Khan Suri's two months in federal custody was being crammed onto an airplane with hundreds of other shackled prisoners.

The Trump administration was trying to deport the Georgetown University scholar over statements he made against Israel's war in Gaza. The guards wouldn't say where they were headed, but the Indian national was convinced it was out of the United States.

Then Khan Suri had to use the plane's bathroom. He said the guards refused to unshackle his wrists.

"They said, 'No, you have to use it like this or do it in your trousers,'" Khan Suri recalled of the trip, taking him to a Louisiana detention center. "They were behaving as if we were animals."

Khan Suri, 41, was released on bond last week as his lawsuit against the U.S.'s deportation case continues. In an interview with The Associated Press, he spoke Thursday of a cramped cell, crowded with other detainees, where he waited anxiously, fearful about what would happen next. He also addressed the



Trump administration's accusations that he spread " Hamas propaganda." Khan Suri said he only spoke in support of Palestinians, who are going through an "unprecedented, livestreamed genocide."

"I don't support Hamas," he said. "I support Palestine. I support Palestinians. And it is so deceiving for some people who just publish canards ... They will just replace Palestine with Hamas."

Yet, because of his comments, he said U.S. authorities treated him as if he had committed a high-level crime. Fellow inmates said his red uniform was reserved for the most dangerous offenders.

"I said, 'No, I'm just a university teacher. I did nothing,'" Khan Suri recalled.

Still, there were rays of hope. He said more than a hundred people from the Georgetown community wrote letters on his behalf to the federal judge overseeing his case, including some who are Jewish.

Won't give in to N-threats: Jaishankar in Germany

External Affairs Minister S Jaishankar on Friday said India has zero-tolerance for terrorism and New Delhi will "never give in to nuclear blackmail".

In his remarks at a joint press conference with his German counterpart Johann Wadepuhl, the external affairs minister also said, "India will deal with Pakistan purely bilaterally" and there should be "no confusion in any quarter" in that regard.

India has a right to defend itself against terrorism, Wadepuhl said, condemning the deadly Pahalgam attack. The German minister's remarks came at a joint press conference with Foreign Minister S Jaishankar in Berlin.

The Union minister is currently in Germany as part of his three-nation Europe visit. Jaishankar told German Chancellor Friedrich Merz that India is looking forward to working with his government to elevate and expand the bilateral strategic partnership.

He also met Minister of Economy and Energy Katherina Reiche.

"Discussed ways to enhance our talent linkages, industry

partnership and joint collaboration to build more resilient supply chains," Jaishankar said.

"I came to Berlin in the immediate aftermath of India responding to the Pahalgam terror attack. Let me share with you what I conveyed to Mr Wadepuhl in that context. India has zero-tolerance for terrorism. India will never give in to nuclear blackmail," he said at the press conference.

"And, India will deal with Pakistan purely bilaterally. There should be no confusion in any quarter in that regard," Jaishankar said.

Pak military spokesman echoes terrorist

Pakistani military spokesperson Lieutenant General Ahmed Sharif Chaudhry issued a threat to India, reportedly using language identical to that of known terrorist Hafiz Saeed. Chaudhry's comments were made at a public gathering, addressing India's recent actions concerning the Indus Waters Treaty. During a speech at a university in Pakistan, Ahmed Sharif Chaudhry reportedly stated, "If you block our water, we will choke your breath." This statement followed India's move to suspend parts of the water-sharing treaty on April 23.

Prisoner swap is underway: Ukraine

US President Donald Trump said Friday that Russia and Ukraine carried out a large exchange of prisoners from their more than three-year war. A Ukrainian official said the swap was ongoing but not yet complete.

Moscow did not immediately confirm the exchange was underway.

"A major prisoners swap was just completed between Russia and Ukraine," Trump said on the Truth Social platform. He said it would "go into effect shortly," although it was not clear what that meant.
