- The Company is pleased to provide the remote e-voting and e-voting facility at the AGM to its members in respect of the business(es) to be transacted at the AGM. The resolutions set forth in the Notice will be transacted only through e-voting. Detailed instructions for e-voting and the procedure to join the AGM, are provided in the Notice.
- The remote e-voting period will commence at 9.00 A.M. (IST) on Saturday, August 16, 2025 and will remain open till 5.00 P.M. (IST) on Tuesday, August 19, 2025. The remote e-voting will not be allowed beyond the aforesaid date & time and the e-voting module shall be forthwith disabled by KFin upon expiry of aforesaid period. Once the vote on the resolutions is casted by the member, he/she shall not be allowed to change it subsequently.
- The cut-off date for the purpose of reckoning the voting rights for this AGM is **Wednesday, August 13, 2025 ("Cut-off date")**. Accordingly, only those members whose names are recorded in the Register of Members or in the Register of Beneficial Owners maintained by the depositories as on Cut-off date (including those members who may not have received this Notice due to non-registration of their email ID with the DPs) shall be entitled to vote by way of remote e-voting/ e-voting at AGM. The person who is not a Member/ Beneficial Owner as on the Cut-off date, should treat this Notice for information purpose only.
- A non-individual member who acquires the equity shares after the Notice is dispatched and holds equity shares as on the Cut-off date, may obtain the login ID and password for e-voting by sending a request at inward.ris@kfintech.com.
