Hamas leader's son, Hezbollah commander killed

Gaza City: An Israeli air strike has killed the son of Hamas' chief negotiator in US-mediated talks over Gaza's future, a senior Hamas official said on Thursday, as leaders of the militant group held talks in Cairo aimed at safeguarding their truce with Israel.

Azzam Al-Hayya, son of Khalil Al-Hayya, succumbed on Thursday after being struck in an Israeli attack on Wednesday night, said senior Hamas official Basim Naim. He is the fourth son of Hamas' exiled Gaza chief to have been killed in Israeli attacks.

The Israeli military did not respond to a request for comment. Hayya, who has seven kids, has survived multiple Israeli attempts to kill him. An Israeli strike in Doha last year targeting Hamas leadership killed his son, though Hayya survived. Two other sons were killed in past Israeli attempts on his life, in Gaza strikes in 2008 and 2014.

Speaking to Al Jazeera on Wednesday night, before his son's death was announced, Hayya accused Israel of trying to undermine mediators' efforts to push ahead with US President Trump's Gaza plan, overseen by his so-called

"Board of Peace".

Israel said it killed a commander of Hezbollah's elite Radwan force in an airstrike on Beirut on Wednesday, the first Israeli attack on the Lebanese capital, Beirut, since a ceasefire agreed

last month.

The Israeli military said the commander was killed when Israel struck the southern suburbs of Beirut. There was no immediate confirmation from Hezbollah. —Agencies

Suspended death sentence for China's ex-defence ministers

In an unprecedented purge of the People's Liberation Army (PLA), two former Chinese defence ministers were sentenced to death with a two-year reprieve on Thursday. Wei Fenghe, 72, and Li Shangfu, 68, were convicted by a military court on graft charges. Wei was found guilty of accepting bribes, while Li was convicted of both offering and accepting them.

Both men were former members of the Central Military Commission (CMC) and previously led the Rocket Force, which controls China's missile systems. Under Chinese law, a death sentence with reprieve is typically commuted to life imprisonment after two years if the suspects cooperate. The court ruled that no further parole or commutation would be permitted. Since taking power in 2012, President Xi Jinping has punished over two million officials to consolidate power and ensure the military remains under the Communist Party of China (CPC).

WAR SNIPPETS

UAE SNEAK FOUR OIL TANKERS VIA STRAIT

The UAE has been able to sneak some of its oil tankers through the strait directly under Iran's nose, according to experts and shipping data. The UAE's Abu Dhabi National Oil Co managed to export at least 6 million barrels of its crude in April aboard four tankers sailing through the Gulf, tracking data from Kpler and SynMax showed. The tankers were able to either unload their shipment to other vessels bound for Southeast Asia, dock in Oman, or sail directly to refineries in South Korea, three sources told Reuters. The journey the four ships took demonstrates the risks producers and buyers are willing to take to free up oil sales despite Iran's threats to attack a vessel daring to cross the strait without permission.

TURKIYE UNVEILS ITS FIRST ICBM

Turkiye has unveiled a prototype of an intercontinental ballistic missile as part of a push to become self-reliant and to gain a foothold as a key defence player in West Asia and among its Nato allies. The ICBM, Yildirimhan, unveiled at the defence and aerospace exhibition in Istanbul, has a range of 6,000km. If launched from Turkiye, it will be able to hit targets across Europe, Africa and Asia.

ISRAEL: PROBING SOLDIER'S ACT

Israel's military has said it is probing an Israeli soldier who was photographed smoking and placing another cigarette on the mouth of a statue of the Virgin Mary in occupied southern Lebanon. The picture was taken in the Christian village of Debel, where another soldier was photographed last month hitting a statue of Jesus on a cross in the face with a sledgehammer. IDF said it viewed the incident with "utmost severity" and the conduct of the soldier "completely deviates from the values expected of its personnel".

PEZESHKIAN: MET MOJTABA RECENTLY

Iran's President Masoud Pezeshkian said on Thursday he met Supreme Leader Mojtaba Khamenei, who has not been seen in public since his appointment in early March. Pezeshkian did not say when their meeting took place.

# विदिशा रेलवे स्टेशन पर टिकट के लिए लंबी कतारें, यात्रियों की छूट रहीं ट्रेनें

विदिशा, (अतुल शाह)। देश में रेलवे के आधुनिकीकरण और हाईस्पीड ट्रेनों की चर्चा के बीच विदिशा रेलवे स्टेशन पर यात्रियों को आज भी एक साधारण टिकट लेने के लिए भारी परेशानियों का सामना करना पड़ रहा है। स्टेशन के प्लेटफॉर्म नंबर-1 पर इन दिनों केवल एक ही टिकट काउंटर चालू होने से यात्रियों की लंबी कतारें लग रही हैं। हालात यह है कि महिला, पुरुष और बुजुर्ग यात्री एक ही लाइन में घंटों खड़े रहने को मजबूर हैं। टिकट लेने में देरी के कारण कई यात्रियों की ट्रेन तक छूट रही है।



स्थिति इतनी खराब हो चुकी है कि कई यात्री मजबूरी में बिना टिकट यात्रा करने को विवश हो रहे हैं। यात्रियों का कहना है कि यदि लाइन में लगे तो ट्रेन निकल जाती है और यदि ट्रेन पकड़ें तो टिकट नहीं मिल पाता। ऐसे में लोग जोखिम उठाकर बिना टिकट यात्रा कर रहे हैं। इससे यात्रियों को जुमाने का डर बना रहता है, वहीं रेलवे विभाग को भी राजस्व का नुकसान उठाना पड़ रहा है। यात्रियों ने बताया कि प्लेटफॉर्म नंबर-4 पर टिकट विंडो नहीं होने से परेशानी और अधिक बढ़ गई है। प्लेटफॉर्म नंबर-4 से ट्रेन पकड़ने वाले यात्रियों को टिकट लेने के लिए प्लेटफॉर्म नंबर-1 तक आना पड़ता है।

यात्रियों का कहना है कि यह समस्या कोई एक-दो दिन की नहीं बल्कि कई दिनों से

लगता बनी हुई है। सुबह और शाम के समय जब मेमो और पैसेंजर ट्रेनों का दबाव बढ़ता है, तब टिकट काउंटर पर भीड़ और अधिक बढ़ जाती है। एक ही खिड़की से टिकट वितरण होने के कारण लोगों को काफी समय तक इंतजार करना पड़ता है। कई बार लाइन इतनी लंबी हो जाती है कि यात्री टिकट लेने और ट्रेन पकड़ने के बीच असमंजस में फंस जाते हैं।
