ISI pushes new gangster faces as pressure mounts on Dawood Ibrahim

Pressure has been mounting on Dawood Ibrahim as Indian security agencies have dismantled several modules linked to his network in recent months. In response, Pakistani handlers are believed to have recalibrated their approach, with the Inter-Services Intelligence (ISI) seeking to divert attention from Dawood and reduce the scrutiny surrounding him.

Investigators found that the name of Pakistan-based gangster Abid Jatt surfaced re-

peatedly during the probe into recent recruitment drives allegedly conducted by ISI asset Shahzad Bhatti. Several recruits, who were reportedly offered money to carry out targeted shootings and gather sensitive information, were also instructed to promote Jatt's profile. As part of this effort, they were directed to put up posters of Jatt at various locations.

An Intelligence Bureau official said the posters were not intended merely to glorify the gangster. While Bhatti allegedly sought to use them to create an atmosphere of terror, investigators believe the main

objective was to shift attention away from the Dawood gang. "The ISI is keen to keep Dawood's name out of the spotlight for the time being," the official said.

It began with the busting of the underworld-linked modules by the Delhi Police Special Cell. It was said that the Dawood gang recruited them. A detailed probe led the investigators to Bhatti as the man who was running these modules. Investigators also found repeated references to Jatt, with Bhatti reportedly directing recruits to popularise Jatt's name through publicity across

parts of north India.

Officials said that Jatt does not operate an independent syndicate and remains part of the Dawood network. According to an official, Jatt's profile has been deliberately projected recently to divert attention from Dawood and his operations.

Another official said that whenever Dawood's name resurfaces, attention turns to allegations regarding terror financing and his links with Lashkar-e-Taiba (LeT) and Jaish-e-Mohammed (JeM).

Action in Begusarai gang-rape case escalates

The investigation into the heinous gang-rape and brutalisation of a woman in Bihar's Begusarai district, that is reminiscent of the 2012 Nirbhaya gang-rape case in the na-

tional Capital, intensified on Friday. Senior officials of Bihar Police launched a detailed enquiry into the shocking case and took disciplinary action against the Chakia SHO Rajiv Ranjan on Friday, for negligence.

The case, which pertains to an incident reported in the Chakia police station area on the night of June 11, gained

widespread attention after allegations surfaced that a bullet, piece of wood and a stone were later recovered from the victim's private parts during medical treatment.

Begusarai Range DIG, Shailesh Kumar Sinha, visited the victim at Sadar Hospital and met her family members to gather information about the horrific crime.

He also reviewed the progress of the investigation with police officials and sought details regarding the action taken so far in the case.

The DIG subsequently held discussions with the medical team, including the Civil Surgeon, and obtained a detailed briefing on the victim's examination and treatment.

HC order upholding Bengal Assembly Speaker's decision challenged at higher bench

Veteran Trinamool Congress legislator Sovande Chatterjee on Friday moved a division bench of the Calcutta High Court, challenging the order of the single-judge bench of Justice Krishna Rao of the same court, upholding the decision of the West Bengal Assembly Speaker Rathindra Bose accepting expelled Trinamool legislator Ritabrata Banerjee as the leader of the new majority bloc of the party in the House as well as the official Leader of Opposition (LoP). Although, in the court order pronounced on Thursday, Justice Rao refused to give any interim direction on the Speaker's decision to accept Ritabrata Banerjee as the LoP, he said that the matter will continue to be heard in his bench and the next hearing in the matter will be held on July 28.

However, before the next date of hearing at Justice Rao's bench, Sovande Chatterjee had approached a division bench of the Calcutta High Court challenging the single-judge bench order. Justice Rao directed both the petitioner and the defendant in the matter to file affidavits in the matter by the next date of hearing. At present, there are 80 Trinamool Congress legislators in the 294-seat West Bengal Assembly. Out of the 80, a total of 60 legislators are officially in the rebel but majority bloc, which Ritabrata Banerjee claimed to be 64 earlier this week. On the other hand, the original Trinamool bloc, who continue their allegiance to party supremo Mamata Banerjee and her nephew Abhishek Banerjee, has the support of just 20 legislators. Meanwhile, a Criminal Investigation Department (CID) probe is already underway over alleged mismatches in the signatures of certain Trinamool legislators in the resolution submitted to the Speaker's office nominating Sovande Chatterjee as the Leader of Opposition (LoP).

6 Guj students suspended, removed from hostel

Gujarat's Health Department has ordered strict disciplinary action against six students of the Government Medical College in Bhavnagar after an investigation into a ragging complaint found them guilty, with one student suspended for two years and all six ordered to vacate their hostel rooms immediately.

The action followed a marathon meeting of the college's Anti-Ragging Committee, which began at 5 p.m.

on June 18 and continued until 2 a.m. on Friday.

The meeting was convened on the instructions of State Health Minister Praful Pansheriya after the alleged ragging incident was reported.

According to the Health Department, the case was treated with urgency by officials in Gandhinagar,

the Additional Director and the Anti-Ragging Committee.

During the nine-hour meeting, written statements were obtained from first-year, second-year and third-year students of the Orthopaedics Department, as well as from concerned faculty members and support staff.

Niger airport attack: 35 die

At least 35 people were killed after gunmen attacked Niger's largest airport in the capital, Niamey, on Thursday. The Defence Ministry said the dead included 22 assailants, 11 soldiers and 20 civilians, while 20 suspects were arrested.

Indian jurist ITLOS judge

Indian jurist Bimal Patel has been elected as a judge of the International Tribunal for the Law of the Sea (ITLOS), the Permanent Mission of India to the UN announced. Patel is a member of the UN International Law Commission and Vice-Chancellor of Rashtriya Raksha University.

Sikh couple 'killer' held

Pakistan police have arrested the prime suspect in the murder of a Sikh caretaker couple shot dead inside a gurdwara in Mardan district of Khyber Pakhtunkhwa province. The victims, Jagannath and Asma Wanti, were killed on Wednesday.

PoK shut over unrest

Pakistan-occupied Kashmir came to a standstill on Thursday following a territory-wide shutdown after nearly two weeks of unrest left at least 24 people dead. The protests were triggered by a dispute over the reservation of 12 assembly seats for refugees ahead of July 27 elections.

Tokyo blaze: 300 rescued

Around 300 students and teachers were evacuated or rescued after a fire broke out at an elementary school in central Tokyo on Friday. The blaze started near a music room on the top floor of the four-storey building. One teacher and several children suffered minor injuries.

Seal colony devastated

Bird flu has killed over 75% of southern elephant seal pups on Australia's remote Heard Island, a new study has found. Researchers estimate over 13,000 of the island's 17,000 baby seals died from the H5N1 strain since August.

"He believes in this deal and will see it to completion. If Iran does not comply, we retain every tool and point of leverage we have today," Vance told re-

porters at the White House. Several Republican senators questioned the deal's strategic value. Senator Bill Cassidy called the conflict's outcome the "worst foreign policy blunder in decades", saying Iran's nuclear ambitions remained intact while sanctions relief and reconstruction benefits were being offered.
