Samrat Choudhary doesn't deserve to be Bihar CM: PK



Jan Suraaj Party (JSP) founder Prashant Kishor has been a vocal critic of Bihar chief minister Samrat Choudhary, even before the BJP leader assumed office on April 15 this year. In an interview with **Free Press**, Kishor claimed that even BJP workers were unhappy with Choudhary. Kishor also spoke about his plans for Bankipur, which he wrested from the BJP in a recent by-election, and the ongoing Gen-Z protests.

Q: You have consistently attacked Samrat Choudhary for a long time. Why are you so opposed to him?

A: Samrat Choudhary does not deserve to hold the post of chief minister given his background. Even BJP workers are not ready to accept him as chief minister, so one can imagine the sentiment among others. We will continue to put pressure on the BJP's central leadership to replace the present chief minister and appoint someone deserving the post.

Q: There is a perception that the BJP had other options for chief minister but Nitish Kumar insisted on Samrat Choudhary as his successor. What is your assessment?

A: That is not true. BJP is misleading people by spreading the impression that Nitish Kumar backed Samrat Choudhary as his successor. Samrat was the BJP's choice, not Nitish's. The BJP wanted to satisfy the JD (U) rank and file by creating such a false impression.

Q: Can you turn Bankipur into a model constituency for other legislators to emulate?

A: I hope so. We are trying to fulfill all the promises we made, including ensuring that people get their full ration, providing quality education and creating employment opportunities. We plan to shift children from government schools to private schools and also bear the financial expenditure over it if quality education is not provided in government schools within a year. Apart from our pre-poll commitments, we have now also pledged to facilitate 10,000 private-sector jobs for educated youth from Bankipur.

The vehicle was parked by the roadside near Mawsikar village, a few metres from the Assam Police camp, when it caught fire around 4 am. The incident was reported to the Langpih Border Outpost in Meghalaya's West Khasi Hills district by the Mawsikar village headman.

Gen Alpha hits streets to seek infra boost in govt schools

School students belonging to Gen Alpha across Rajasthan, Uttar Pradesh, Madhya Pradesh and Bihar are taking to the streets to demand urgent infrastructure improvements and adequate teaching staff in government schools.

Following June-July agitations over national exam irregularities, younger students have launched protests over basic deficiencies like dilapidated buildings, unhygienic toilets, lack of drinking water and missing subject teachers. In Rajasthan's Rampura Kanwarpura, protests forced the state government to sanction a new building after students were found attending classes in a cattle enclosure. Similar demonstrations oc-

curred in Ajmer against administrative harassment and in Jaipur, where speech- and hearing-impaired students staged a dharna over unsanitary facilities.

In UP, students blocked major traffic intersections across Lucknow, Unnao, Fatehpur and Kannauj.

Boy, 6, draws attention for bold comments

Patna: Aditya, a six-year-old slum-dwelling boy, has become the centre of attention for his bold and sharp comments during a students' protest here. Dressed in a T-shirt and denim trousers and sporting a traditional 'tilak' on his forehead, Aditya participated in the protest over demands related to Bihar Public Service Commission (BPSC) examinations on Tuesday. Later, he was handed over to his parents by the police.

215 RGHS pharmacies face action in Raj

Authorities have temporarily suspended 215 private pharmacies from processing transactions under the Rajasthan Government Health Scheme (RGHS) for alleged negligence and delays in dispensing medicines, officials said on Wednesday.

The state's Principal Secretary, Medical and Health, Gayatri Rathore, said the department was continuously monitoring the medicine distribution system under RGHS.

Pharmacies that had allegedly failed to make medicines available to beneficiaries for a prolonged period were given an opportunity to submit explanations.

Youth held for playing Mujahid song with Tipu cutout

Chickmagalur police have arrested 23-year-old Aafridi, who had posted a video of a 40-feet tall Tipu cutout, playing Mujahid music in the background.

Afraid, who works in a car showroom of Chickmagalur town was handling an Instagram Account titled 'Chickmagalur Power Tipu Boys' and has posted the video on his instagram.

The Chickmagalur police have also interrogated at least 24 associates of Aafridi to ascertain if they had any role in creating the video.

Chickmagalur Superintendent of Police Jitendra Kumar Dayama said that Aafridi has been remanded to 14-day judicial custody, while his associ-

ates were let go after confirming that the entire group had no role in the controversial video.

Fior the last five to ten years, the youths in Chickmagalur used to get police permission to celebrate Eid-Milad festival and take out a procession. The police had given permission to celebrate the festival as previous years and not permitted any new cutouts. However, a 40-feet tall Tipu cutout was erected and Aafridi had uploaded the video of the cutout, with Mujahid song and songs mentioning Pakistan.

He had also shared the video through WhatsApp and had sent the content through direct messages for many of his contacts, Jitendra Kumar Dayama added.
