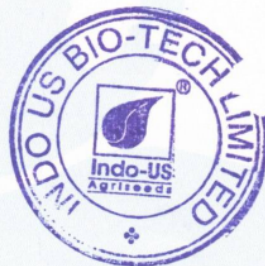
The Board, at their Meeting held on 21<sup>st</sup> April, 2026 has accepted the resignation of the director with effect from same date.
