साइबर ठग गिरोह के सरगना सहित दो पकड़े

पंचकूला, 12 जुलाई (जनसत्ता)।

साइबर पुलिस 9.68 करोड़ रुपए की ठगी में दो साइबर शक्ति को गिरफ्तार कर लिया है। धरपकड़ का यह अभियान पुलिस आयुक्त शिवास कविराज और पुलिस उपाधीक्षक पंचकूला हिमाद्रि कौशिक नीत दल की ओर से चलाया गया, जिसमें साइबर थाना प्रभारी ललित कुमार व दल ने साइबर ठगी के बड़े मामले का भंडाफोड़ करने में सफलता पाई।

अभियान में ग्रेवाल एवैन्यू, पटियाला वासी मुख्य आरोपी जितन जितल (आइटी विशेषज्ञ) और पटियाला के गांव गनौर के निवासी साथी मुस्ताक मोहम्मद को गिरफ्तार किया गया।

जानकारी के मुताबिक पंचकूला, सेक्टर-7 वासी पीडित ललित सिंगला ने शिकायत दी कि मनीमाजरा में स्वर्णभूषणों की दुकान है। एक दिन उनके पास 'वाट्सअप ग्रुप' में जुड़ने का

जीरकपुर कार्यालय खोलने पहुंचा था सरगना, वहीं गिरफ्तार कर लिया गया। पुलिस अदालत से दोनों का रिमांड मांगेगी और 'फ्रीज' रकम की बरामदगी करेगी।

एक लिंक आया। वहां जुड़ने के बाद उन्हें शेयर बाजार संबंधी संदेश मिलने लगे। 'ग्रुप एडमिन' के कहने पर उन्होंने अंतरराष्ट्रीय नंबर पर जेम्स नामक व्यक्ति से बात की, जिसने उनका 'ट्रेडिंग अकाउंट' खोल दिया। इसके बाद उसके जरिये ट्रेडिंग करने के लिए उनसे पहले 38 लाख रुपए, फिर साढ़े आठ लाख रुपए, 38 लाख रुपए, 10 लाख रुपए और 77.18 लाख रुपए हस्तांतरित कराए गए। ठगों की ओर से उनसे कुल 18 बार रकम हस्तांतरित कराई गई। साइबर अपराधियों ने बाद में यह रकम दोगुनी दिखाकर ठगी की।

जब शिकायतकर्ता ने जमा रकम लौटाने को कहा, तो उन्हें पहले दस फीसद टैक्स जमा करने को कहा गया और फिर उन्होंने उन्हें 'एप्पल फोन' भेजने का प्रलोभन देना शुरू किया। जब पीडित ने वेबसाइट की जांच कराई तो वह फर्जी निकली। इसके बाद पीडित ने साइबर थाना, सेक्टर 12 में शिकायत दी और उसी आधार पर मामला दर्ज किया गया।

साइबर ठग गिरोह का सरगना जितन जितल आइटी स्नातक है, कई राज्यों के साइबर गिरोहों से जुड़ा है और फर्जी खाते खुलवाकर उनके नाम पर कमीशन लेता था। जब वह जीरकपुर में कार्यालय खोलने आया तो उसे गिरफ्तार कर लिया गया। उसके बाद मुस्ताक मोहम्मद को भी गिरफ्तार किया गया। दोनों को शुक्रवार अदालत में पेश कर रिमांड में लिया जाएगा। इसके अलावा, संबद्ध बैंक खातों में 'फ्रीज' रकम भी बरामद की जाएगी।

पंचायत प्रतिनिधियों की बढ़ेगी पेंशन

पंचकूला, 12 जुलाई (जनसत्ता)।

हरियाणा के मुख्यमंत्री नायब सिंह ने शुक्रवार को पंचकूला में आयोजित राज्य स्तरीय पंचायत-सम्मलेन में पंचायतीराज संस्थाओं के लिए कई घोषणाएं की। मुख्यमंत्री ने पंचायतीराज प्रतिनिधियों की पेंशन में बढ़ोतरी करने की घोषणा की।
