We would like to clarify that the report delivered to the Bank on April 26, 2025 (the “Report”) (in respect of which the Bank had made a disclosure on April 27, 2025) has identified certain aspects which may require a determination from an “insider trading perspective”. The Bank is examining these findings in the Report and based on the outcome of such examination, the Bank will take the necessary steps under applicable law (including the Bank’s Insider Trading Code).

We are conscious of our disclosure obligations under Regulation 30 of the Listing Regulations and shall continue to comply with the same.
