The accompanying Statement includes unaudited interim financial results and other financial information in respect of one wholly owned subsidiary whose unaudited financial results includes total revenue Rs.0.00 Crore, Other Income Rs.0.31 Crore, Total net profit/(loss) after tax of Rs.0.21 Crores and total comprehensive income / (loss) of Rs.0.15 Crores for the quarter ended June 30, 2026, as considered in the statement. The financial results of the said subsidiary have not been reviewed by any auditors whose financial information results have been furnished to us by the Management and our conclusion on the statement in so far as it relates to the amounts and disclosures included in respect of this entity, is based solely on the management certified information and the procedures performed by us as described in paragraph 3 above. According to the information and explanation given to us by the management, these interim financial results are not material to Group.
