In continuation to our letter dated December 12, 2025 and in accordance with the provisions of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”), we would like to inform you that the INM House Private Limited (INM House), a wholly owned subsidiary of the Company has today i.e. December 26, 2025 obtained the consent of its shareholders for its voluntary dissolution and will thereafter make an application for strike-off and dissolution with the Registrar of Companies.

INM House was incorporated on November 21, 2023 and has not commenced its operations post incorporation.

Pursuant to the above, INM House shall cease to be a subsidiary of the Company upon completion of the process of the voluntary strike-off and dissolution.

The requisite details pursuant to the SEBI Listing Regulations read with SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 is enclosed as an Annexure A.
