Sr. No.	Particulars	Details of Dadar Diagnostic Centre
1.	Existing capacity	The Company along with its subsidiaries currently operate 7 diagnostic centres and 1 centralised laboratory.
2.	Existing capacity utilization	Capacity utilisation is not ascertainable in quantifiable terms, as the Company operates in the diagnostic services segment, which does not have a defined or standardised production capacity. The volume of services rendered varies based on patient inflow, test mix, diagnostic complexity, equipment usage duration and operating hours. Hence, capacity utilisation cannot be measured in conventional or numerical terms.
3.	Proposed capacity addition	This capacity addition pertains to the commencement of new diagnostic modalities, namely PET-CT scan, CT scan, Sonography (SONO), Pathology and X-Ray services, at the Dadar Centre (Primacare Diagnostic LLP, a subsidiary of the Company), which was earlier under development and had not commenced commercial operations.
4.	Period within which the proposed capacity is to be added	Commercial Operations started on 30 January, 2026.
5.	Investment required	The investment is approximately ₹550 lakhs, which includes cost of equipment, installation and allied expenses.
6.	Mode of financing	Company Funds.
7.	Rationale	The Dadar centre was earlier under construction and interior fit-out activities and had not commenced diagnostic operations. The proposed commencement of services will enable the Company to expand its diagnostic service offerings and strengthen its geographical presence.
