Chandigarh Even as the Municipal Corporation has claimed that the water supply would remain at low pressure on Sunday due to repair at Kajali waterworks, residents faced an acute shortage of water and complained there was no supply at all. Asked queries by residents, the officials said that the water supply had been cut for technical snag and it would take a lot of time to repair the same, maybe more than two days. Swedish Talwar, president of Residents Welfare Association of Sector 44-B, Chandigarh, said, "I have been told that after the repair work is over, the pumping motors have burnt out. The pipe of 30 diameter will take a huge time to replace. So there won't be any supply." The Municipal Corporation had issued an alert on Saturday specifying that due to a fault in the main supply line, the water supply in the pipelines at Kajali waterworks, the drinking water supply will be at low pressure for two days, starting Sunday.
