## Iris Clothings Reports Strong Q1FY26 Performance

**Profit After Tax Grew by 8.7% YoY in Q1FY26, Highlighting Strong Operational Efficiency**  
**Strategic Initiatives Drive Growth as Company Focuses on Long-Term Growth**

- **Profit after Tax** stood at Rs. 26.3 Mn in Q1FY26 as against Rs. 24.2 Mn in Q1FY25 a growth of 8.7%

Also, company has allotted Bonus Equity Share in the ratio of 1:1 to the members of the Company on 7<sup>th</sup> July 2025.*

*Looking ahead, we plan to expand our production capacity to reach 38,000 pieces per day. We are excited to introduce our new inner wear line and enhance our sportswear offerings, underscoring our commitment to innovation and quality. We anticipate strong growth driven by organic demand and new capacity additions, while also focusing on enhancing our retail D2C segment to accelerate our growth trajectory and deliver greater value to our stakeholders.
