PROCEEDINGS OF THE 13TH ANNUAL GENERAL MEETING OF THE SHAREHOLDERS OF M/S. IRIS CLOTHINGS LIMITED HELD ON SATURDAY, 28TH SEPTEMBER, 2024 AT 11:00 A.M. THROUGH VIDEO-CONFERENCING (VC)/ OTHER AUDIO-VISUAL MEANS (OAVM)

The 13th Annual General Meeting ("AGM" / "Meeting") of the Company was held on Saturday, 28th September, 2024 at 11:00 a.m. through Video Conferencing (VC)/ Other Audio-Visual means (OAVM).

The Meeting was conducted in accordance with the circulars issued by the Ministry of Corporate Affairs ('MCA') and the Securities and Exchange Board of India ('SEBI'). Mrs. Sweta Agarwal, Company Secretary, welcomed the Members to the Meeting and introduced the Board of Directors present at the Meeting.

All the Directors were present at the Meeting. Mr. Nikhil Saraf, the Chairperson of the Audit Committee, Stakeholders Relationship Committee and Nomination and Remuneration Committee was also present at the AGM. Mr. Bhupendra Bhutia, representative of Statutory Auditor and Mr. Rajesh Ghorawat, Secretarial Auditor and Scrutinizer for the remote e-voting and the e-voting during the AGM, were also present at the Meeting through VC/OAVM. Requisite Quorum being present through Video Conferencing, Mrs. Sweta Agarwal, requested Mr. Santosh Ladha, Managing Director to chair the meeting and commence the proceedings of the Meeting.

The Chairman welcomed the members who were present at the meeting through Video Conferencing (VC)/ Other Audio-Visual means (OAVM). Total 50 members attended the meeting.

The Chairman then proceeded to deliver his speech, giving an overview of the financial performance and operations of the Company for the Financial Year 2023-24.

The Company Secretary informed the members that pursuant to the provisions of the Companies Act, 2013 read with Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the Listing Regulations), the Company has provided a facility to its members to exercise their right to vote electronically for the 13th Annual General Meeting through remote electronic voting (e-voting) service facilitated by the Central Depository Services (India) Limited (CDSL), on all the resolutions set out in the AGM Notice. The remote e-voting facility commenced on 25th September, 2024 at 9:00 A.M. and ended on 27th September, 2024 at 5:00 P.M. The shareholders who are present at this virtual meeting and who have not or could not exercise their vote through remote e-voting option, could vote at this meeting. The Board of Directors had appointed Mr. Rajesh Ghorawat, Practicing Company Secretary, as the Scrutinizer for this meeting. The Voting Results along with Scrutinizer Report would be submitted to Stock Exchange within 2 working days of the conclusion of the meeting and would be available on the website of the Company and CDSL. The Register of Directors and Key Managerial Personnel and their Shareholding and Register of Contracts or Arrangements in which directors are interested were made available for online inspection by the members.

With the consent of the Chairman, the Notice convening the AGM, the Board's Report and the Auditor's Report were taken as read.

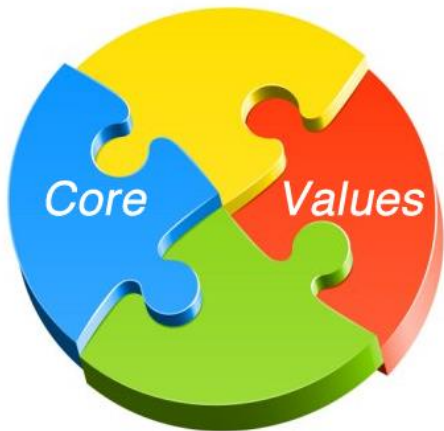

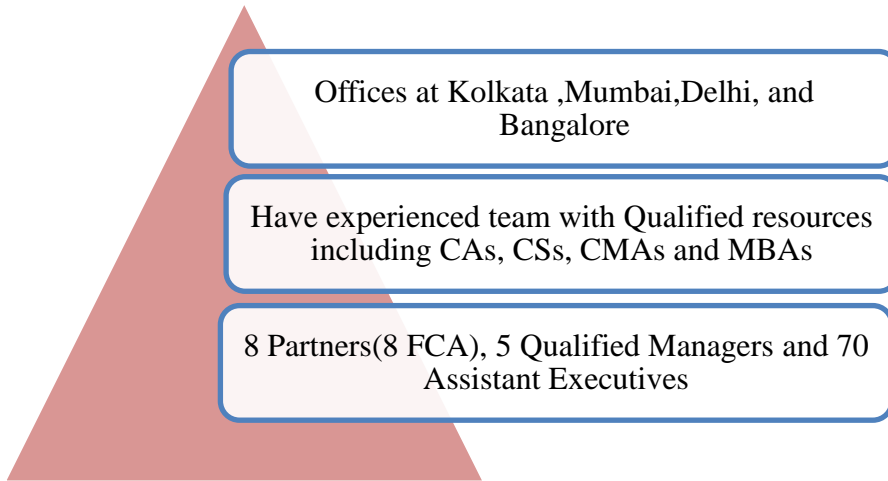
