Pursuant to Regulation 30 read with Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that Mr. Gautam Mahanti, designated as Senior Management Personnel and Head – GST, ceased to be associated with the Company with effect from August 01, 2025.

This development is in line with the completion of divestment of the Company's GST ASP Services Business in favour of IRIS Logix Solutions Private Limited ("IRIS Logix") in terms of the Business Transfer Agreement dated July 02, 2025 entered into between the Company and IRIS Logix. Following the said business transfer, Mr. Gautam Mahanti, who was heading the Company's GST ASP Services Business, has been transferred to IRIS Logix with effect from August 01, 2025 and is no longer associated with the Company in the above-mentioned capacity.

We confirm that there is no material reason for his cessation other than the one stated above.
