



અમદાવાદને મળશે સર્વયોગમ રેડિયો મ્યુઝિયમનું નજરાણું

અમદાવાદ, તા. ૧૨ વિશ્વમાં શોર્ટવેવ રેડિયોની શરૂઆત થઈ ત્યારે તેનું પ્રસારણ વિશ્વભરમાં એક જગ્યાએ એક સાથે થતું હતું. શોર્ટવેવ સિગ્નલ ધરાવનાર પાસાના ધરતી ધરની અંદર તાંબાની જાળીવાળા બેચલ લગાવવા પડતા હતા. મોટાભાગે વિશ્વમુખ્ય દરમ્યાન પ્રજામાં પોલી અંકગણોથી ભયના ફેલાવા તેના રેડિયો ઉપરથી પ્રસારણ થતાં સમાચારોનું મહત્વ મૂળ વધારે હતું. કે આખા ગામમાં ફક્ત એક કે બે જ રેડિયો હોય અને તેને સાંભળવા બધા સંગા થતા હતા. વાલવ્યાળા મોટી સાઈઝના રેડિયો આવાતા હતા જેમ જેમ ટેકનોલોજીનો વિકાસ થવામાં આવ્યો...

તમ રેડિયામાં પણ પરિવર્તન આવ્યા અને આજે તો યંગ જનરેશનમાં પણ રેડિયો ખૂબ લોકપ્રિય થઈ ગયો. ૧૯૮૧માં અમદાવાદમાં સિદ્ધાર્થ પટેલ પાસે દેશ વિદેશના ૧૨૦થી વધુ રેડિયોનું કલેક્શન જર્મનીની વગેરે અનેક દેશોના વિવિધ પ્રાંતના ૧૨૦થી વધારે વાલવ્યાળા રેડિયોનું કલેક્શન છે. ભારતમાં અમદાવાદ એકમાત્ર હેરિટેજ સિટી તરીકે જાહેર થયું. તો સિદ્ધાર્થ પટેલને એવો વિચાર આવ્યો કે સારી સંખ્યામાં વાલવ્યાળા રેડિયો છે. તો આ સંસ્કૃતિનું એક સરસ રેડિયો મ્યુઝિયમ હોવું જોઈએ. માટે તેમણે સર્વયોગમ રેડિયો મ્યુઝિયમની સ્થાપના કરી. ફેબ્રુઆરીની ૧૩ તારીખે વર્લ્ડ રેડિયો ડેના દિવસે અમદાવાદમાં સર્વયોગમ રેડિયો મ્યુઝિયમનું ઉદ્ઘાટન આકાશવાણીના એક સ આસિસ્ટન્ટ ડાયરેક્ટર મોહન મુનશી સરના હસ્તે થયું.
