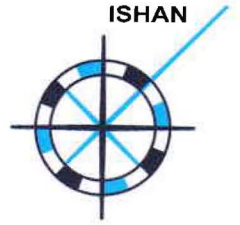



દિલ્હીના લાલ કિલ્લા પાસે થયેલા કાર બ્લાસ્ટ મામલે એક બાદ એક નવા ખુલાસાઓ સામે આવી રહ્યા છે. આ મામલામાં હવે એજન્સી હવાલા ઍંગલની પણ તપાસ કરી રહી છે. ફરીદાબાદની અલ-ફલાહ યુનિવર્સિટીથી શરૂ થયેલા વ્હાઈટ કોલર આતંકી મોઝુલમાં હવે હવાલા નેટવર્કનું મામલો પણ સામે આવ્યો છે. આ ફંડિંગ હવાલા નેટવર્ક મારફતે યુનિવર્સિટીમાંથી ઝડપાયેલા અને હજુ ભાગેલા બે ડોક્ટરો સુધી પહોંચાડવામાં આવી રહી હતી. મીડિયાના એક રિપોર્ટ પ્રમાણે ડોક્ટરોના બેંક ખાતાઓની ટ્રાન્ઝેક્શનની તપાસ થઈ રહી છે. તેમના ખાતાઓમાં છેલ્લા કેટલાક મહિનામાં થયેલા લેવડ-દેવડ ચકાસવામાં આવી રહ્યું છે.

સૂત્રો દ્વારા મળતી માહિતી પ્રમાણે ડોક્ટર ઉમર, ડોક્ટર મુજમ્મિલ અને ડોક્ટર શાહીનના ટ્રાન્ઝેક્શની એજન્સી હાલ તપાસ કરી રહી છે. શરૂઆતી તપાસમાં ૨૦ લાખ રૂપિયા પુરાવાના આધાર પર એજન્સીઓને મળ્યા છે. આ રૂપિયા જેશના હેન્ડલર તરફથી આવ્યા હોવાની શંકા સેવાઈ રહી છે. હવાલા મારફતે જેશ એ આ પૈસા ડોક્ટરો સુધી પહોંચાડ્યા હોવાનું માનવામાં આવી

રહ્યું છે.

ગુમચર એજન્સી સાથે જોડાયેલા સૂત્રોના મુજબ અંદાજે ૩ લાખ રૂપિયા ખાતર ખરીદવામાં ખર્ચ કરવામાં આવ્યા હતા. પૈસા સંબંધિત મુદ્દે ઉમર અને ડોક્ટર શાહીન વચ્ચે ઝઘડો પણ થયો હતો. મુજમ્મિલ પાસેથી તપાસ એજન્સીઓને આ મોટી લીડ મળી છે.

આ બધા આતંકીઓ મેવાતના એક એજન્ટ મારફતે દિલ્હીના હવાલા નેટવર્કના સંપર્કમાં આવ્યા હતા. આ એજન્ટ જ તેમને ટેરર ફંડિંગ માટે હવાલાથી આવતા રૂપિયા પહોંચાડતો હતો. સૌથી પહેલા એજન્ટનો સંપર્ક આતંકી ડોક્ટર શાહીન સાથે થયો હતો, પછી

ડોક્ટર મુજમ્મિલ અને થોડા સમય પહેલાં આતંકી ડોક્ટર ઉમર સાથે પણ સંપર્ક થયો. સૂત્રોના જણાવ્યા અનુસાર ટેરર ફંડિંગની આ રકમ આ આતંકી મોઝુલ સાથે જોડાયેલા આરોપીઓ લોજિસ્ટિક્સથી લઈને દરેક પ્રકારના ખર્ચ માટે વાપરતા હતા. એટલે કે દિલ્હી બ્લાસ્ટ પહેલાં એમોનિયમ નાઈટ્રેટ ખરીદવા, બ્લાસ્ટ માટે વપરાયેલી કાર, બ્લાસ્ટ માટેનું સામાન અને અન્ય ખરીદી માટે રૂપિયા જરૂર પડતા હતા. આ તમામ ખર્ચો હવાલાથી મળતા પૈસાથી જ કરવામાં આવતો હતો.

લગભગ ૬:૩૦ વાગ્યે બની હતી. કોચ્ચુનર કાર (નંબર- MP 07 CG 9006) ઝાંસી તરફથી ગ્વાલિયર તરફ આવી પૂરપાટ દોડતી કાર ટ્રેક્ટર ટ્રોલીમાં ધૂસી રહી હતી. માલવા કોલેજ પાસેના એક વળાંકમાંથી રેતી ભરેલી ટ્રેક્ટર-ટ્રોલી અચાનક હાઈવે પર આવી. કોચ્ચુનરની ગતિ ખૂબ જ તેજ હોવાને કારણે, ડ્રાઈવરને ગાડી પર કાબૂ મેળવવાનો સહેજ પણ મોકો મળ્યો નહીં અને કાર સીધી
