CHAIRMAN'S SPEECH

Chairman's Speech at the 31st Annual General Meeting

Financial Year Ended March 31, 2026

Good morning/afternoon, Ladies and Gentlemen,

On behalf of the Board of Directors of Ishan International Limited, I extend a very warm welcome to each one of you to the 31st Annual General Meeting of your Company. I sincerely thank you, our valued shareholders, for taking the time to join us today, and for the continued trust and confidence you have reposed in the Company over the last three decades.

As we mark this 31st milestone, I would like to take this opportunity to share with you a brief overview of your Company's performance during the financial year 2025-26, the environment in which we operated, and the road ahead.

A Year of Consolidation and Improved Profitability

During the year under review, your Company reported Revenue from Operations of Rs. 2,688.81 Lakhs, as compared to Rs. 7,265.34 Lakhs in the previous financial year. I would like to clarify at the outset that this decline was not a reflection of any underlying weakness in our business. It was primarily on account of a large, one-off bulk supply arrangement with a domestic customer that was executed and fully completed in FY 2024-25, and which did not recur to the same extent during the year under review.

What I am pleased to report, however, is that despite this decline in topline, your Company's profitability actually improved during the year. Profit Before Tax increased to Rs. 53.40 Lakhs from Rs. 28.85 Lakhs, and our Total Comprehensive Income for the year rose to Rs. 41.44 Lakhs from Rs. 23.16 Lakhs in the previous year. This was made possible by a more favourable order and product mix, with material cost as a proportion of revenue improving to approximately 77.6% from approximately 92.8% in the previous year.

This performance reaffirms a philosophy that your Board has consistently held: that sustainable, quality earnings and improving margins are a far more meaningful measure of progress for this Company than topline growth alone, particularly in a business where large project orders can naturally cause revenue to be uneven from year to year.

Given the Company's modest profits and its ongoing requirement of funds to support future growth and expansion, your Board has considered it prudent not to recommend a dividend for the year under review. This decision reflects our strategic intent to reinvest earnings towards strengthening the Company's market position and building long-term shareholder value.

Our Business and Industry Context

Ishan International Limited is a diversified heavy engineering company with a history of over 31 years in marketing and selling heavy engineering equipment in international markets, spanning sugar plants, hydro power plants and pollution control systems. We are proud to be an ISO 9001:2015 certified organisation and a Government of India certified Star Export House.

Since 2005, your Company has promoted over 40 Hydro Power Projects, ranging from 1 MW to 60 MW, across ASEAN countries, and we have built an established presence in Vietnam and Southeast Asia. Our Sugar Machinery export business to ASEAN markets continues, even as we work towards diversifying into new geographies, including Africa and North America. We also continue to strengthen our footprint in pollution control and clean energy technologies, including through the domestic KUSUM Yojna for solar-powered agricultural pumps.

India's engineering goods exports achieved a third consecutive year of record performance during the year, rising to approximately US\$ 122.43 billion in FY 2025-26. This sector continues to be supported by Government initiatives such as the Market Access Initiative Scheme, the Production Linked Incentive Scheme and the Export Promotion Mission, and by sustained demand from infrastructure, power and renewable energy. At the same time, exporters like us continue to navigate global headwinds, including tariff actions in key markets such as the USA, and volatility in global demand and order inflows. Your Board and management remain mindful of these external factors as we plan for the future.

Strengthening Our Foundation

On matters of governance, during the year Mr. Mahesh Bhupathi stepped down from the Board as an Independent Director due to his other pre-occupations, and I would like to place on record, on behalf of the Board, our sincere appreciation for his valuable contribution during his tenure. We subsequently welcomed Mr. Salil Srivastava to the Board as an Independent Director, and I am confident that his experience will add further strength to our deliberations.

Your Company continues to maintain sound and adequate internal control systems commensurate with its size, and a well-defined risk management framework. We remain conscious of the concentration risk that comes from our dependence on a limited number of large-value orders, and diversifying our order book across geographies and customers remains a key priority for your management.

Looking Ahead

As we look to the year ahead, our priorities remain clear: to broaden and diversify our order book, to deepen our presence in existing markets while pursuing opportunities in new geographies, and to continue strengthening our position in the renewable energy and pollution control space, which we believe represents a significant long-term opportunity for this Company. We will continue to prioritise the quality and profitability of our order book over sheer revenue size, a discipline that has served us well this year.

None of this would be possible without the continued support of everyone associated with this Company. I would like to express my sincere gratitude to our shareholders, customers, suppliers, bankers, employees and all other stakeholders for their steadfast support through the year. I would also like to thank my colleagues on the Board for their guidance, and our employees for their dedication, which remains the true foundation of everything we have achieved.

With that, I once again thank you all for being here today, and I now invite you to join us in taking up the items of business set out in the Notice of this Annual General Meeting.

MANAGEMENT DISCUSSION AND ANALYSIS REPORT

For the Financial Year Ended March 31, 2026

1. Snapshot

The Company was originally incorporated as Ishan International Private Limited on May 29, 1995 under the Companies Act, 1956 vide certificate of incorporation issued by the Registrar of Companies, New Delhi. Subsequently the name of the Company was changed to “Ishan International Limited” under the Companies Act, 2013 pursuant to a special resolution passed by our shareholders at the EGM held on January 11, 2022 and had obtained fresh certificate of incorporation on January 17, 2022 issued by the Registrar of Companies, New Delhi. The CIN of the Company is L74899DL1995PLC069144.

Ishan is an ISO 9001:2015 certified Company, GoI certified Star Export House and a diversified heavy engineering company with a history of over 31 years of experience in marketing/selling heavy engineering equipment in international markets. It is engaged in marketing/selling projects that focus on supplying machines, erection/installation, commissioning and operational training for sugar plants, hydro power plants and pollution control systems. It also provides high-end engineering services and solutions for all types of activities in Hydro Power, Sugar & Pollution Control Systems.

2. Industry Overview — Indian Engineering Sector

According to the India Brand Equity Foundation (IBEF) and industry sources, India's capital goods and engineering industry continues to form a strong backbone for multiple sectors such as engineering, construction, infrastructure and consumer goods.

- India's engineering goods exports achieved a third consecutive year of record performance, rising to approximately US\$ 122.43 billion in FY 2025-26, from US\$ 116.67 billion in FY 2024-25 and US\$ 109.30 billion in FY 2023-24.
- Engineering goods continue to be one of the largest contributors to India's merchandise exports, supported by Government initiatives such as the Market Access Initiative (MAI) Scheme, the Production Linked Incentive (PLI) Scheme and the Export Promotion Mission.
- Demand continues to be driven by capacity expansion in infrastructure, power, renewable energy, mining, oil & gas, refineries, steel, automobiles and consumer durables.
- India continues to enjoy a competitive advantage due to low manufacturing costs, technology innovation and a skilled workforce, though exporters continue to navigate global headwinds including tariff actions by key markets such as the USA and volatility in global demand.
- Growing emphasis on Renewable Energy and Pollution Control continues to ensure sustained global demand for the equipment and engineering services in which the Company specialises.

ISHAN'S STRATEGIC POSITIONING & INITIATIVES

Ishan identified the potential of Renewable Energy and Pollution Control equipment exports nearly two decades ago.

- Since 2005, Ishan has promoted over 40 Hydro Power Projects (1 MW – 60 MW) across ASEAN countries, with an established presence in Vietnam and Southeast Asia.
- The Company continues to focus on its export of Sugar Machinery and related equipment to ASEAN countries, and continues to pursue diversification into new geographies, including Africa and North America.
- The Company continues to strengthen its presence in pollution control and clean energy technologies.

REVIEW OF OPERATIONS

During the year under review, Revenue from Operations stood at Rs. 2,688.81 Lakhs, as compared to Rs. 7,265.34 Lakhs in the previous financial year. The decline in revenue is primarily on account of the large one-off bulk supply arrangement with a domestic customer that was executed and fully completed during FY 2024-25, and did not recur to the same extent during the year under review. Total Expenses correspondingly declined to Rs. 2,716.67 Lakhs from Rs. 7,325.98 Lakhs in the previous year, broadly in line with the reduction in material costs on lower revenue.

Despite the decline in the topline, the Company's profitability improved on account of a better cost structure and improved operating margins. Profit before tax increased to Rs. 53.40 Lakhs from Rs. 28.85 Lakhs, and total comprehensive income for the year increased to Rs. 41.44 Lakhs from Rs. 23.16 Lakhs in the previous financial year, reflecting the Company's continued focus on growth and profitability, rather than revenue alone, as its key performance metric. Basic and diluted earnings per share for the year stood at Rs. 0.02 as compared to Rs. 0.01 in the previous financial year.

Material cost as a proportion of revenue from operations improved to approximately 77.6% during FY 2025-26 from approximately 92.8% in FY 2024-25, reflecting a more favourable order and product mix during the year. Employee benefits expense and finance costs were also lower during the year, in line with the scale of operations, while depreciation and amortization expense increased, reflecting continued investment in the Company's fixed assets.

Foreign Exchange Earnings and Outgo: The Company continues to derive a significant proportion of its business from exports, and remains exposed to fluctuations in foreign exchange rates. Details of foreign exchange earnings and outgo for the year are provided in the Notes to the Standalone Financial Statements forming part of this Annual Report.

the Quality Management System under ISO 9001:2015. During the year under review, the Company remained mindful of concentration risk arising from dependence on a limited number of large-value orders, and continues to work towards diversifying its order book across geographies and customers.

6. Environment, Health & Safety

The Company is committed to complying with applicable health, safety and environmental regulations and other requirements in its operations. Compliances are strictly met and monitored, and the Company continues to invest in energy-efficient office operations and safe working practices for its employees.

7. Internal Control System

The Company has sound and adequate internal control systems commensurate with its size and the nature of its business. During the year under review, such controls were tested and no reportable material weakness in the design or operations was observed.

8. Material Developments in Human Resources / Industrial Relations

Human capital remains the Company's most essential asset. The number of permanent employees on the rolls of the Company are same as 16 as on March 31, 2026, from 16 as on March 31, 2025, reflecting the Company's continued investment in its people to support its growth objectives. The Company continues to prioritise a supportive and collaborative work environment where safety, occupational health and environmental stewardship remain central. Consistent and periodic training continues to enhance employee morale and confidence, driving the Company towards achieving its strategic objectives.

I have also relied upon the representations made by the Company and its officers for systems and mechanisms formed by the Company for compliances under other applicable laws, rules and regulations.

Further, I have also examined compliance with:

- i. Secretarial Standards issued by The Institute of Company Secretaries of India with respect to Board Meetings and General Meetings;

ii. The Listing Agreement entered into by the Company with the National Stock Exchange of India Limited read with the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Compliance Status

During the Audit Period, the Company has generally complied with the provisions of the Act, Rules, Regulations, Guidelines and Standards mentioned above and has filed the requisite forms and returns with the appropriate authorities. Certain filings were made beyond the prescribed timelines upon payment of additional fees and were duly approved/taken on record by the Ministry of Corporate Affairs.

However, during the course of Secretarial Audit of the Company for the financial year ended March 31, 2026, and based on the records, documents, information, explanations and management representations provided to us, the following observations are noted:

- 1. No Penalty Imposed by SEBI / NSE** — Based on the information and records made available to us, no penalty was imposed on the Company by SEBI or NSE during the financial year under review.
- 2. SEBI Investigation Communication and NSE Query on IPO Fund Utilisation** — The Company received communication / mail from SEBI in relation to investigation / information requirements, and the Company has submitted its reply to the same. Further, NSE had sought certain information / clarification regarding utilisation of IPO proceeds, and as informed to us, the Company has duly replied to the said query.
- 3. Agenda Item Relating to Mutual Fund Details** — It was observed that the agenda of the Board Meeting dated February 18, 2026, particularly Agenda Item No. 5, did not contain complete details / particulars relating to mutual fund investments / transactions, wherever applicable.
- 4. Structured Digital Database Compliance** — The Company has maintained Structured Digital Database; however, it was observed that the SDD was not properly complied with / maintained in complete form, as certain past data was not available due to a technical glitch in the software. The Company is advised to ensure complete and proper maintenance of SDD with adequate backup and audit trail going forward.
- 5. Emphasis of Matters Reported by Statutory Auditor in Financial Results for the Year Ended March 31, 2026** — We also draw attention to the Emphasis of Matters reported by the Statutory Auditor in the financial results / financial statements of the Company for the financial year ended March 31, 2026, as under:
 - a.** The Company is yet to complete the formalities of seeking extension of time from the Reserve Bank of India in respect of delay in recovery of dues from foreign customers outstanding for a period exceeding 270 days from the date on which such dues became payable.
 - b.** As per Ind AS 109 “Financial Instruments”, the Company is required to consider provision for Expected Credit Loss on all financial assets based on the expected probability of recoverability of such financial instruments. During the half year ended March 31, 2026, the Company has provided ₹37.99 lakhs towards Expected Credit Loss in the financial statements.

c. During the year, the Company obtained approval from its Authorized Dealer Bank for write-off of export receivables amounting to ₹87,56,185, and the same has been adjusted against Expected Credit Loss credited in earlier years.

d. During the year, the Company adjusted ₹1,808.74 lakhs from advances given to suppliers against the credit balance of one of the parties to whom advances were given. As informed, all parties have filed consent terms for the same and accordingly, the adjustment has been made.

The above observations are based on the records produced before us, information and explanations provided by the management, and the audit verification carried out during the period under review.

I further report that:

The Board of Directors of the Company is duly constituted with an appropriate balance of Executive Directors, Non-Executive Directors and Independent Directors. Changes in the composition of the Board, if any, during the Audit Period were carried out in compliance with the applicable provisions of the Act.

Adequate notice was given to all Directors to schedule the Board Meetings. Agenda papers and detailed notes on agenda items were circulated in advance and a system exists for seeking and obtaining further information and clarifications on agenda items before the meetings to facilitate meaningful participation and informed decision-making.

All decisions at the Board Meetings and Committee Meetings were carried unanimously, as recorded in the minutes of the respective meetings.

We further report that there are adequate systems and processes in the Company commensurate with its size and operations to monitor and ensure compliance with applicable laws, rules, regulations and guidelines.

Further, during the Audit Period, in certain instances, e-Forms were filed beyond the prescribed timelines due to technical issues on the MCA portal. Such filings were subsequently completed upon payment of applicable additional fees.

Report on the Audit of the Standalone Ind AS Financial Statements

Opinion

We have audited the accompanying standalone Ind AS Financial Statements of **Ishan International Limited** (hereinafter referred to as “Company”), which comprise the Balance Sheet as at March 31, 2026 the Statement of Profit and Loss (including other comprehensive income) and the Cash Flow Statement and the Statement of Changes in Equity for the year ended on that date, and notes to the standalone Ind AS financial statements, including a summary of the significant accounting policies and other explanatory information (herein after referred to as “the standalone Ind AS financial statements”).

In our opinion and to the best of our information and according to the explanations given to us the aforesaid standalone Financial Statements give the information required by the Companies Act, 2013 (“the Act”) in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company, as at March 31, 2026, its profit including other comprehensive income, their cash flows and the statement of changes in equity for the year ended on that date.

Basis for Opinion

We conducted our audit of the standalone Ind AS financial statements in accordance with the Standards on Auditing specified under section 143(10) of the Act (SAs). Our responsibilities under those Standards are further described in the *Auditor's Responsibilities for the Audit of the Standalone Financial Statements* section of our report. Emphasis of Matters

1. We draw your attention to Note no. 34(a) of financial statements, As per Ind AS 109 “Financial Instrument” the company is required to consider “Provision for Expected

Credit Loss” on all financial assets on the basis of expected probability of recoverability of such financial instrument. During the year ended on 31st March 2026, the company has provided Rs. 75.99 Lacs towards Expected Credit Loss in the financial statement.

2. We draw your attention to Note no. 38 to the financial statements, The management is actively in consultation with the authorised dealer bank for seeking an extension of time from the Reserve Bank of India (RBI) in respect of delays in the realization of export receivables from certain foreign customers, which have remained outstanding for a period exceeding 270 days from their respective due dates.
3. We draw your attention to Note no. 35 of financial statements, During the year the company has adjusted Rs.1808.74 Lakhs from the advance given to supplier against credit balance of one of the creditor based on the consent agreement entered into between the company, the supplier and the parties to whom the advances were given. All parties have filed consent terms for the same and hence the adjustment has been made.
4. We draw your attention to Note no. 34(b) of financial statements, During the year the company has got approval from their Authorised Dealer (Bank) for write of export receivables amounts to Rs.87.56 Lakhs and the same has been adjusted against ECL credited in earlier years.

Our opinion is not modified in respect of these matters of emphasis.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the standalone Ind AS financial statements of the current period. These matters were addressed in the context of our audit of the standalone financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

We have determined that there are no matters that require communication as key audit matters in our report.

Information Other than the Standalone Financial Statements and Auditor’s Report Thereon

The Company’s Management and Board of Directors are responsible for the preparation of the other information. The other information comprises the information included in the Company’s annual report, but does not include the standalone Ind AS financial statements and our auditor’s report thereon.

Our opinion on the standalone Ind AS financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

1 Significant Accounting Policies
a Company Overview

Ishan International Limited. ("the Company") is a limited Company incorporated in India having its registered office at New Delhi, India. The Company is in Engineering , Procurement and Construction (EPC) Business. The Company was registered as Private Limited Company under the provisions of The Companies Act, 1956 and got converted in to Limited company on 17th January, 2022. It's Equity Shares are Listed at National Stock Exchange (NSE)

b Basis of Preperation

The Company's financial statements have been prepared in accordance with the provisions of the Companies Act, 2013 and the Indian Accounting Standards ("Ind AS") notified under the Companies (Indian Accounting Standards) Rules, 2015 and amendments thereof issued by Ministry of Corporate Affairs in exercise of the powers conferred by section 133 of the Companies Act, 2013. In addition, the guidance notes/announcements issued by the Institute of Chartered Accountants of India (ICAI) are also applied except where compliance with other statutory promulgations require a different treatment. These financials statements have been approved for issue by the Board of Directors at their meeting held on 20th May, 2026.

c Basis of Accounting

The Company maintains its accounts on accrual basis following historical cost convention, except for certain financial instruments that are measured at fair value in accordance with Ind AS. Fair value measurements are categorised as below based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the company can access at measurement date;
Level 2 inputs are inputs, other than quoted prices included in level 1, that are observable for the asset or liability, either directly or indirectly; and
Level 3 inputs are unobservable inputs for the valuation of assets or liabilities.

d Presentation of financial statements

The Balance Sheet and the Statement of Profit and Loss are prepared and presented in the format prescribed in the Schedule III to the Companies Act, 2013 ("the Act"). The Statement of Cash Flows has been prepared and presented as per the requirements of Ind AS 7 "Statement of Cash Flows". The disclosure requirements with respect to items in the Balance Sheet and Statement of Profit and Loss, as prescribed in the Schedule III to the Act, are presented by way of notes forming part of the financial statements along with the other notes required to be disclosed under the notified Accounting Standards and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended.

e Operating cycle for current and non-current classification

Operating cycle for the business activities of the company covers the duration of the specific project/contract/ product line/service including the defect liability period wherever applicable and extends up to the realisation of receivables (including retention monies) within the agreed credit period normally applicable to the respective lines of business.

f Use of judgement and estimates

The preparation of the financial statements in conformity with Ind AS requires management to make certain estimates, judgements and assumptions. These affect the application of accounting policies, the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities at the reporting date of the financial statements and reported amounts of income and expenses during the period. Accounting estimates could change from period to period and the actual results could differ from those estimates. These are reviewed by the management on an on-going basis and appropriate changes in estimates are made prospectively as management becomes aware of changes in circumstances surrounding the estimates. Changes in estimates are reflected in the financial statements in the period in which changes are made and, if material, their effects are disclosed in the notes to the financial statements.

The management believes that the estimates used in preparation of these financial statements are just, prudent and reasonable.

g Exceptional Items

An item of income or expense which by its size, type or incidence requires disclosure in order to improve an understanding of the performance of the Company is treated as an exceptional item and disclosed as such in the financial statements.

h Property, Plant and Equipment (PPE)

PPE is recognised when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. PPE is stated at original cost net of tax/duty credits availed, if any, less accumulated depreciation and cumulative impairment, if any. PPE acquired on hire purchase basis are recognised at their cash values. Cost includes professional fees related to the acquisition of PPE and for qualifying assets, borrowing costs capitalised in accordance with the Company's accounting policy.

Own manufactured PPE is capitalised at cost including an appropriate share of overheads. Administrative and other general overhead expenses that are specifically attributable to construction or acquisition of PPE or bringing the PPE to working condition are allocated and capitalised as a part of the cost of the PPE.

PPE not ready for the intended use on the date of the Balance Sheet are disclosed as "capital work-in-progress". (Also refer to policy on leases, borrowing costs, impairment of assets and foreign currency transactions infra).

Depreciation is recognised using written Down value method so as to write off the cost of the assets (other than freehold land and properties under construction) less their residual values over their useful lives specified in Schedule II to the Companies Act, 2013, or in the case of assets where the useful life was determined by technical evaluation, over the useful life so determined. Depreciation method is reviewed at each financial year end to reflect the expected pattern of consumption of the future economic benefits embodied in the asset. The estimated useful life and residual values are also reviewed at each financial year end and the effect of any change in the estimates of useful life/ residual value is accounted on prospective basis.Where cost of a part of the asset ("asset component") is significant to total cost of the asset and useful life of that part is different from the useful life of the remaining asset, useful life of that significant part is determined separately and such asset component is depreciated over its separate useful life

Depreciation on additions to/deductions from, owned assets is calculated pro rata to the period of use. Extra shift depreciation is provided on a location basis.

Depreciation charge for impaired assets is adjusted in future periods in such a manner that the revised carrying amount of the asset is allocated over its remaining useful life. Assets acquired under finance leases are depreciated on a straight line basis over the lease term. Where there is reasonable certainty that the Company shall obtain ownership of the assets at the end of the lease term, such assets are depreciated based on the useful life adopted by the Company for similar assets.

Freehold land is not depreciated

i Foreign currency Transactions

Transactions arising in foreign currencies during the year are converted at the rates closely approximating the rates ruling on the transaction dates. Liabilities and receivables in foreign currency are restated at the year-end exchange rates. All exchange rate differences arising from conversion in terms of the above are included in the statement of profit and loss

j Revenue Recognition

Ind AS 115: The objective of this Standard is to establish the principles that an entity shall apply to report useful information to users of financial statements about the nature, amount, timing and uncertainty of revenue and cash flows arising from a contract with a customer.

Identifying the Contract

An entity shall account for a contract with a customer that is within the scope of this Standard only when all of the following criteria are met:

- (a) the parties to the contract have approved the contract (in writing, orally or in accordance with other customary business practices) and are committed to perform their respective obligations;
- (b) the entity can identify each party's rights regarding the goods or services to be transferred;
- (c) the entity can identify the payment terms for the goods or services to be transferred;
- (d) the contract has commercial substance (ie the risk, timing or amount of the entity's future cash flows is expected to change as a result of the contract); and
- (e) it is probable that the entity will collect the consideration to which it will be entitled in exchange for the goods or services that will be transferred to the customer. In evaluating whether collectability of an amount of consideration is probable, an entity shall consider only the customer's ability and intention to pay that amount of consideration when it is due. The amount of consideration to which the entity will be entitled may be less than the price stated in the contract if the consideration is variable because the entity may offer the customer a price concession.

Identifying Performance Obligation:

At contract inception, an entity shall assess the goods or services promised in a contract with a customer and shall identify as a performance obligation each promise to transfer to the customer either: (a) a good or service (or a bundle of goods or services) that is distinct; or 596 (b) a series of distinct goods or services that are substantially the same and that have the same pattern of transfer to the customer.

Satisfaction of performance obligations:

An entity shall recognise revenue when (or as) the entity satisfies a performance obligation by transferring a promised good or service (i.e. an asset) to a customer. An asset is transferred when (or as) the customer obtains control of that asset.

Performance obligations satisfied over time

When either party to a contract has performed, an entity shall present the contract in the balance sheet as a contract asset or a contract liability, depending on the relationship between the entity's performance and the customer's payment. An entity shall present any unconditional rights to consideration separately as a receivable.

Measurement

When (or as) a performance obligation is satisfied, an entity shall recognise as revenue the amount of the transaction price (which excludes estimates of variable consideration) that is allocated to that performance obligation.

Determining the transaction price

An entity shall consider the terms of the contract and its customary business practices to determine the transaction price. The transaction price is the amount of consideration to which an entity expects to be entitled in exchange for transferring promised goods or services to a customer, excluding amounts collected on behalf of third parties (for example, some sales taxes). The consideration promised in a contract with a customer may include fixed amounts, variable amounts, or both.

k Investments:

Under Ind AS, these financial assets have been classified as Fair Value through Profit or Loss (FVTPL) on the date of transition and fair value changes after the date of transition has been recognised in profit or loss.

l Fair value measurement :

The fair values of the financial assets and liabilities are included at the amount at which the instrument could be exchanged in a current transaction between willing parties.

The following methods and assumptions were used to estimate the fair values:

- (a) Fair value of current assets which includes loans given, cash and cash equivalents, other bank balances and other financial assets - approximate their carrying amounts.
- (b) Financial instruments with fixed and variable interest rates are evaluated by the Company based on parameters such as interest rates and individual credit worthiness of the counterparty. Based on this evaluation, allowances are taken to account for expected losses of these receivables. Accordingly, fair value of such instruments is not materially different from their carrying amounts.

m Borrowings

Borrowing costs include interest expense calculated using the effective interest method, finance charges in respect of assets acquired on finance lease and exchange differences arising on foreign currency borrowings to the extent they are regarded as an adjustment to interest costs.

Borrowing costs net of any investment income from the temporary investment of related borrowings that are attributable to the acquisition, construction or production of a qualifying asset are capitalised/inventoried as part of cost of such asset till such time the asset is ready for its intended use or sale. A qualifying asset is an asset that necessarily requires a substantial period of time to get ready for its intended use or sale. All other borrowing costs are recognised in Profit or Loss in the period in which they are incurred.

n Financial Instruments

Financial assets and/or financial liabilities are recognised when the company becomes party to a contract embodying the related financial instruments. All financial assets, financial liabilities and financial guarantee contracts are initially measured at transaction values and where such values are different from the fair value, at fair value. Transaction costs that are attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from as the case may be, the fair value of such financial assets or liabilities, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in Profit or Loss.

In case of funding to subsidiary companies in the form of interest free or concession loans and preference shares, the excess of the actual amount of the funding over initially measured fair value is accounted as an equity investment.

A financial asset and a financial liability is offset and presented on net basis in the balance sheet when there is a current legally enforceable right to set-off the recognised amounts and it is intended to either settle on net basis or to realise the asset and settle the liability simultaneously.

(i) Financial Assets

(A) All recognised financial assets are subsequently measured in their entirety either at amortised cost or at fair value depending on the classification of the financial assets as follows:

(i) Investments in debt instruments that are designated as fair value through profit or loss (FVTPL) - at fair value.

(ii) Investments in debt instruments that meet the following conditions are subsequently measured at - at amortised cost (unless the same designated as fair value through profit or loss):

The asset is held within a business model whose objective is to hold assets in order to collect contractual cash flows; and

The contractual terms of instrument give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

(iii) Investment in debt instruments that meet the following conditions are subsequently measured at fair value through other comprehensive income [FVTOCI] (unless the same are designated as fair value through profit or loss)

The asset is held within a business model whose objective is achieved both by collecting contractual cash flows and selling financial assets; and

The contractual terms of instrument give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

- (iv) Debt instruments at FVTPL is a residual category for debt instruments, if any, and all changes are recognised in profit or loss.
- (v) Investment in equity instruments issued by subsidiary, associate and joint venture companies are measured at cost less impairment.
- (vi) Investment in preference shares of the subsidiary companies are treated as equity instruments if the same are convertible into equity shares or are redeemable out of the proceeds of equity instruments issued for the purpose of redemption of such investments. Investment in preference shares not meeting the aforesaid conditions are classified as debt instruments at FVTPL.
- (vii) Investments in equity instruments are classified as at FVTPL, unless the related instruments are not held for trading and the Company irrevocably elects on initial recognition to present subsequent changes in fair value in Other Comprehensive Income.
- (B) For financial assets that are measured at FVTOCI, income by way of interest and dividend, provision for impairment and exchange difference, if any, (on debt instrument) are recognised in profit or loss and changes in fair value (other than on account of above income or expense) are recognised in other comprehensive income and accumulated in other equity. On disposal of debt instruments at FVTOCI, the cumulative gain or loss previously accumulated in other equity is reclassified to profit or loss. In case of equity instruments at FVTOCI, such cumulative gain or loss is not reclassified to profit or loss on disposal of investments.
- (C) A financial asset is primarily derecognised when:
 - (i) the right to receive cash flows from the asset has expired, or
 - (ii) the company has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a pass-through arrangement; and (a) the company has transferred substantially all the risks and rewards of the asset, or (b) the company has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

On derecognition of a financial asset in its entirety, the difference between the carrying amounts measured at the date of derecognition and the consideration received is recognised in Profit or Loss.

- (D) Impairment of financial assets: The Company recognises impairment loss on trade receivables using expected credit loss model, which involves use of a provision matrix constructed on the basis of historical credit loss experience as permitted under Ind AS 109. Impairment loss on investments is recognised when the carrying amount exceeds its recoverable amount.
 - (ii) **Financial Liabilities**
 - (i) Financial liabilities, including derivatives and embedded derivatives, which are designated for measurement at FVTPL are subsequently measured at fair value. Financial guarantee contracts are subsequently measured at the amount of impairment loss allowance or the amount recognised at inception net of cumulative amortisation, whichever is higher. All other financial liabilities including loans and borrowings are measured at amortised cost using Effective Interest Rate (EIR) method.
- A financial liability is derecognised when the related obligation expires or is discharged or cancelled.

Inventories

Inventories are valued after providing for obsolescence, as under:

- (i) Raw materials, components, construction materials, stores, spares and loose tools at lower of weighted average cost or net realisable value. However, these items are considered to be realisable at cost if the finished products in which they will be used, are expected to be sold at or above cost.
- (ii) Manufacturing work-in-progress at lower of weighted average cost including related overheads or net realisable value. In some cases, manufacturing work-in-progress are valued at lower of specifically identifiable cost or net realisable value. In the case of qualifying assets, cost also includes applicable borrowing costs vide policy relating to borrowing costs.
- (iii) Finished goods and stock-in-trade (in respect of goods acquired for trading) at lower of weighted average cost or net realisable value. Cost includes related overheads and GST paid/payable on such goods.
- (iv) Completed property/work-in-progress (including land) in respect of property development activity at lower of specifically identifiable cost or net realisable value.

Assessment of net realisable value is made at each reporting period end and when the circumstances that previously caused inventories to be written-down below cost no longer exist or when there is clear evidence of an increase in net realisable value because of changed economic circumstances, the write-down, if any, in the past period is reversed to the extent of the original amount written-down so that the resultant carrying amount is the lower of the cost and the revised net realisable value.

p Cash and Bank Balances

Cash and bank balances also include fixed deposits, margin money deposits, earmarked balances with banks and other bank balances which have restrictions on repatriation. Short term and liquid investments being subject to more than insignificant risk of change in value, are not included as part of cash and cash equivalents.

q Securities Premium Account

Securities premium includes:

- (i) The difference between the face value of the equity shares and the consideration received in respect of shares issued.
- (ii) The issue expenses of securities which qualify as equity instruments are written off against securities premium account.

r Employee Benefits

(i) Short Term Employee Benefits

Employee benefits such as salaries, wages, short term compensated absences, expected cost of bonus, ex-gratia and performance-linked rewards falling due wholly within twelve months of rendering the service are classified as short term employee benefits and are expensed in the period in which the employee renders the related service.

(ii) Post Employment Benefits

- (a) **Defined contribution plans:** The Company's superannuation scheme, state governed provident fund scheme, employee state insurance scheme and employee pension scheme are defined contribution plans. The contribution paid/payable under the schemes is recognised during the period in which the employee renders the related service.

- (b) **Defined Benefit Plans:** The employees' gratuity fund schemes and employee provident fund schemes managed by board of trustees established by the Company, the post-retirement medical care plan and the Company pension plan represent defined benefit plans. The present value of the obligation under defined benefit plans is determined based on actuarial valuation using the Projected Unit Credit Method.

The obligation is measured at the present value of the estimated future cash flows using a discount rate based on the market yield on government securities of a maturity period equivalent to the weighted average maturity profile of the defined benefit obligations at the Balance Sheet date.

Re-measurement, comprising actuarial gains and losses, the return on plan assets (excluding amounts included in net interest on the net defined benefit liability or asset) and any change in the effect of asset ceiling (if applicable) is recognised in other comprehensive income and is reflected in retained earnings and the same is not eligible to be reclassified to profit or loss. Defined benefit costs comprising current service cost, past service cost and gains or losses on settlements are recognised in the Statement of Profit and Loss as employee benefits expense. Interest cost implicit in defined benefit employee cost is recognised in the Statement of Profit and Loss under finance cost. Gains or losses on settlement of any defined benefit plan are recognised when the settlement occurs. Past service cost is recognised as expense at the earlier of the plan amendment or curtailment and when the company recognises related restructuring costs or termination benefits.

In case of funded plans, the fair value of the plan assets is reduced from the gross obligation under the defined benefit plans to recognise the obligation on a net basis.

(iii) Long Term Employee benefits

The obligation recognised in respect of long term benefits such as compensated absences, long service award etc. is measured at present value of estimated future cash flows expected to be made by the Company and is recognised in a similar manner as in the case of defined benefit plans vide (ii)(B) supra.

Long term employee benefit costs comprising current service cost and gains or losses on curtailments and settlements, re-measurements including actuarial gains and losses are recognised in the Statement of Profit and Loss as employee benefit expenses. Interest cost implicit in long term employee benefit cost is recognised in the Statement of Profit and Loss under finance cost.

(iv) Terminal Benefits

Termination benefits such as compensation under employee separation schemes are recognised as expense when the Company's offer of the termination benefit is accepted or when the Company recognises the related restructuring costs whichever is earlier.

s Taxes on Income

Tax on income for the current period is determined on the basis of taxable income and tax credits computed in accordance with the provisions of the Income Tax Act, 1961 and based on the expected outcome of assessments/appeals.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the Company's financial statements and the corresponding tax bases used in computation of taxable profit and quantified using the tax rates and laws enacted or substantively enacted as on the Balance Sheet date.

Deferred tax liabilities are generally recognised for all taxable temporary differences including the temporary differences associated with investments in subsidiaries and associates, and interests in joint ventures, except where the company is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

Deferred tax assets are generally recognised for all taxable temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets relating to unabsorbed depreciation/business losses/losses under the head "capital gains" are recognised and carried forward to the extent of available taxable temporary differences or where there is convincing other evidence that sufficient future taxable income will be available against which such deferred tax assets can be realised.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Company expects, at the end of reporting period, to recover or settle the carrying amount of its assets and liabilities.

Transaction or event which is recognised outside Profit or Loss, either in Other Comprehensive Income or in equity, is recorded along with the tax as applicable.

t Leases

Ind AS 116 – Leases which sets out the principles for the recognition, measurement, presentation and disclosure of leases for both parties to a contract and replaces the previous standard on leasing, Ind AS 17 – Leases. Ind AS 116 eliminates the classification of leases for the lessee as either operating leases or finance leases as required by Ind AS 17 and instead, introduces a single lessee accounting model whereby a lessee is required to recognise assets and liabilities for all leases with a term that is greater than 12 months, unless the underlying asset is of low value, and to recognise depreciation of leased assets separately from interest on lease liabilities in the income statement.

The accounting by lessors under the new standard is substantially unchanged from today's accounting in Ind AS 17. Lessors classify all leases using the same classification principle as in IAS 17 and distinguish between two types of leases: operating and finance leases. For operating leases, lessors continue to recognize the underlying asset. For finance leases, lessors derecognize the underlying asset and recognize a net investment in the lease similar to today's requirements. Any selling profit or loss is recognized at lease commencement.

u Provisions, contingent Liabilities and Contingent Assets

Provisions are recognised only when

(i) the Company has a present obligation (legal or constructive) as a result of a past event; (ii) it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation; and

(iii) a reliable estimate can be made of the amount of the obligation.

Provision is measured using the cash flows estimated to settle the present obligation and when the effect of time value of money is material, the carrying amount of the provision is the present value of those cash flows. Reimbursement expected in respect of expenditure required to settle a provision is recognised only when it is virtually certain that the reimbursement will be received.

Contingent liability is disclosed in case of:

(i) a present obligation arising from past events, when it is not probable that an outflow of resources will be required to settle the obligation; and

(ii) a present obligation arising from past events, when no reliable estimate is possible. Contingent assets are disclosed where an inflow of economic benefits is probable.

Provisions, contingent liabilities and contingent assets are reviewed at each Balance Sheet date.

Where the unavoidable costs of meeting the obligations under the contract exceed the economic benefits expected to be received under such contract, the present obligation under the contract is recognised and measured as a provision.

v Statement of Cash Flows

Statement of Cash Flows is prepared segregating the cash flows into operating, investing and financing activities. Cash flow from operating activities is reported using indirect method, adjusting the profit before tax excluding exceptional items for the effects of:

(i) changes during the period in inventories and operating receivables and payables transactions of a non-cash nature;

(ii) non-cash items such as depreciation, provisions, unrealised foreign currency gains and losses; and

(iii) all other items for which the cash effects are investing or financing cash flows.

Cash and cash equivalents (including bank balances) shown in the Statement of Cash Flows exclude items which are not available for general use as at the date of Balance Sheet.

Credit risk arises from the possibility that the counter party may not be able to settle their obligations as agreed. To manage this, the Company periodically assesses financial reliability of customers and other counter parties, taking into account the financial condition, current economic trends, and analysis of historical bad debts and ageing of financial assets. Individual risk limits are set and periodically reviewed on the basis of such information.

The Company considers the probability of default upon initial recognition of asset and whether there has been a significant increase in credit risk on an ongoing basis through each reporting period. To assess whether there is a significant increase in credit risk the Company compares the risk of default occurring on asset as at the reporting date with the risk of default as at the date of initial recognition. It considers reasonable and supportive forwarding- looking information such as:

- Actual or expected significant adverse changes in business,
